The U. T. System Board of Regents will convene a Special Called Meeting from 10:00 a.m. to approximately 3:30 p.m. on January 7, 2022, according to the following agenda. The presiding officer will be present at the location listed above, which will be open to the public during the open portions of the meeting, and other Board members may participate by video conference call via Zoom. The posted meeting is currently planned to be held in-person with a quorum of the Board physically present at the meeting site; however, because of the uncertainty of assured attendance by members of the Board, agency staff, and other required participants, this posting also provides the required statutory notice that the meeting may be held using a videoconference call format as authorized by state law should circumstances make an in-person meeting impossible or impractical.
