# **INTRODUCTION**

# 1.1 Description of The University of Texas System

For more than 130 years, The University of Texas System ("**UT System**" and "**University**") has been committed to improving the lives of Texans and people all over the world through education, research and health care.

The University of Texas System is one of the nation's largest systems of higher education, with 14 institutions that educate more than 217,000 students. Each year, UT institutions award more than one-third of all undergraduate degrees in Texas and almost two-thirds of all health professional degrees. With about 20,000 faculty – including Nobel laureates – and more than 70,000 health care professionals, researchers student advisors and support staff, the UT System is one of the largest employers in the state.

The UT System ranks third in the nation in patent applications, and because of the high caliber of scientific research conducted at UT institutions, the UT System is ranked No. 1 in Texas and third in the nation in federal research expenditures. In addition, the UT System is home to three (3) of the nation's National Cancer Institute Cancer Centers – UT MD Anderson, UT Southwestern and UT Health Science Center-San Antonio – which must meet rigorous criteria for world-class programs in cancer research.

Chancellor William H. McRaven's ambitious vision for the UT System includes eight "Quantum Leaps," that address many of the most significant challenges of our time, including building the nation's next generation of leaders through core education in leadership and ethics; leading a brain health revolution by accelerating discoveries and treatments for neurological diseases; elevating higher education's role in national security; driving unprecedented levels of collaboration between higher and K-12 education; and increasing student access and success.

Other numerous transformational initiatives implemented over the past several years have cemented UT as a national leader in higher education, including the expansion of educational opportunities in South Texas with the opening of The University of Texas Rio Grande Valley in the fall of 2015. And UT is the only system of higher education in the nation establishing not one (1), but two (2) new medical schools in 2016 at The University of Texas at Austin and UT Rio Grande Valley.

University of Texas institutions are setting the standard for excellence in higher education and will continue do so thanks to our generous donors and the leadership of the Chancellor, the Board of Regents and UT presidents.

# 1.2 Background and Special Circumstances

The System's Office of Employee Benefits ("**OEB**") is located at the System's headquarters in Austin, Texas, and has responsibility for the oversight of all fully-insured and self-funded benefit plans provided as part of the UT Benefits program. Maximizing the benefits and services that eligible System employees, retired employees, and their covered dependents receive for each dollar spent on benefits is a primary objective for OEB.

OEB is considered a "Covered Entity" under Title 2 of the Health Insurance Portability and

Accountability Act (HIPAA) of 1996, Public Law 104-191, 1996. As such, OEB must comply with all provisions of HIPAA and the Health Information Technology for Economic and Clinical Health Act (HITECH), 45 CFR §§ 160 and 164 (hereinafter collectively, "HIPAA") regarding all privacy and security measures relevant to the operations of the programs within OEB when operating in a capacity subject to HIPAA. Additionally, any person or entity who performs functions or activities on behalf of, or provides certain services to a covered entity that involve access to protected health information are considered business associates under HIPAA. OEB requires appropriate Business Associate Agreements with such vendors.

There are approximately 123,000 benefits-eligible employees and retired employees plus approximately 116,000 dependents participating in benefit plans through the System's Uniform Group Insurance Program, a key component of the UT Benefits package. The Benefits package includes insurance, retirement, and wellness programs. The System's benefits-eligible subscribers consist of 79% employees, 19% benefits-eligible retired employees, and 2% of other subscriber categories. There are approximately 850 COBRA participants continuing coverage in various plans within the program. Covered subscribers live primarily in Texas but a small number of employees either reside or work outside of Texas. Although most retired System employees reside in Texas, there are also a number of retired employees who live in other states or countries.

The System offers a self-funded, preferred provider ("PPO") health plan ("UT SELECT") for eligible participants. Approximately 120,000 employees, retired employees, and COBRA subscribers along with 89,000 dependents are covered by UT SELECT. UT SELECT medical benefits are currently administered by Blue Cross and Blue Shield of Texas, and prescription benefits are currently administered by Express Scripts, Inc., formerly Medco Health Solutions.

UT System intends to contract for claims audit services for the self-funded plans provided to the participants of the UT SELECT Plan and the UT DENTAL SELECT Plan. The term of the engagement will be for an initial three (3) year contract with the possibility of two (2) yearly renewals for a total possible contract timeframe of five (5) years (ref. **Section 5** of this RFP). The audit for the initial contract period will cover the Plan Years 2017, 2018, and 2019.

# 1.3 Objective of Request for Proposal

The University of Texas System is soliciting proposals in response to this Request for Proposal No.720-1807 (this "RFP"), from qualified vendors to provide claims audit services (the "Services") more specifically described in Section 5 of this RFP, including auditing (1) claims administration and adjudication; (2) compliance with plan design; and (3) performance criteria established in each respective administrator's RFP Response.

# 1.4 Group Purchase Authority

Texas law authorizes institutions of higher education (defined by §61.003, *Education Code*) to use the group purchasing procurement method (ref. §§51.9335, 73.115, and 74.008, *Education Code*). Additional Texas institutions of higher education may therefore elect to enter into a contract with the successful Proposer under this RFP. In particular, Proposer should note that University is part of The University of Texas System (**UT System**), which is comprised of fourteen institutions described at <a href="http://www.utsystem.edu/institutions">http://www.utsystem.edu/institutions</a>. UT System institutions routinely evaluate whether a contract resulting from a procurement conducted by one of the institutions might be suitable for use by another, and if so, this RFP could give rise to additional purchase volumes. As a result, in submitting its proposal, Proposer should consider proposing a pricing model and other commercial terms that take into account the higher volumes and other expanded opportunities that could result from the eventual inclusion of other institutions in the purchase contemplated by this RFP. Any purchases made by other institutions based on this RFP will be the sole responsibility of those institutions.

University specifically instructs all interested parties to restrict all contact and questions regarding this RFP to written communications delivered to (i) University Contact, or (ii) if questions relate to Historically Underutilized Businesses, to HUB Coordinator (ref. **Section 2.5** of this RFP). *University Contact must receive all questions or concerns no later than 2:30 p.m. CST on Thursday, November 9th, 2017.* University will have a reasonable amount of time to respond to questions or concerns. It is University's intent to respond to all appropriate questions and concerns; however, University reserves the right to decline to respond to any question or concern.

### 2.3 Criteria for Selection

The successful Proposer, if any, selected by University through this RFP will be the Proposer that submits a proposal on or before the Submittal Deadline that is the most advantageous to University. The successful Proposer is referred to as "Contractor."

Proposer is encouraged to propose terms and conditions offering the maximum benefit to University in terms of (1) service, (2) total overall cost, and (3) project management expertise.

The evaluation of proposals and the selection of Contractor will be based on the information provided in the proposal. University may consider additional information if University determines the information is relevant.

Criteria to be considered by University in evaluating proposals and selecting Contractor, will be these factors:

### 2.3.1 Threshold Criteria Not Scored

- A. Ability of University to comply with laws regarding Historically Underutilized Businesses; and
- B. Ability of University to comply with laws regarding purchases from persons with disabilities.

### 2.3.2 Scored Criteria

- A. Cost (50%)
- B. Experience (30%);
- C. Approach to Project Services (20%).

#### 2.5 **Historically Underutilized Businesses**

- All agencies of the State of Texas are required to make a good faith effort to assist historically underutilized businesses (each a "HUB") in receiving contract awards. The goal of the HUB program is to promote full and equal business opportunity for all businesses in contracting with state agencies. Pursuant to the HUB program, if under the terms of any agreement or contractual arrangement resulting from this RFP. Contractor subcontracts any of the Services, then Contractor must make a good faith effort to utilize HUBs certified by the Procurement and Support Services Division of the Texas Comptroller of Public Accounts. Proposals that fail to comply with the requirements contained in this Section 2.5 will constitute a material failure to comply with advertised specifications and will be rejected by University as non-responsive. Additionally, compliance with good faith effort guidelines is a condition precedent to awarding any agreement or contractual arrangement resulting from this RFP. Proposer acknowledges that, if selected by University, its obligation to make a good faith effort to utilize HUBs when subcontracting any of the Services will continue throughout the term of all agreements and contractual arrangements resulting from this RFP. Furthermore, any subcontracting of the Services by Proposer is subject to review by University to ensure compliance with the HUB program.
- 2.5.2 University has reviewed this RFP in accordance with 34 TAC §20.285, and has determined that subcontracting opportunities are probable under this RFP.
- 2.5.3 A HUB Subcontracting Plan ("HSP") is a required as part of, but submitted separately from, Proposer's proposal. The HSP will be developed and administered in accordance with University's Policy on Utilization of Historically Underutilized Businesses and incorporated for all purposes.

Each Proposer must complete and return the HSP in accordance with the terms and conditions of this RFP. Proposers that fail to do so will be considered non-responsive to this RFP in accordance with §2161.252, Government Code.

Proposer must complete the HSP, then print, sign and scan *all pages* of the HSP Option selected <u>to the submittal email address noted above</u>. NOTE: signatures must be "wet" signatures. Digital signatures are not acceptable.

Any proposal submitted in response to this RFP that does not have a corresponding HSP meeting the above requirements may be rejected by University and returned to Proposer unopened as non-responsive due to material failure to comply with advertised specifications.

University will send an email confirmation to each Proposer upon receipt of the Proposer's HSP. Each Proposer's HSP will be evaluated for completeness and compliance prior to opening the proposal to confirm Proposer compliance with HSP rules and standards. Proposer's failure to submit one (1) completed and signed HUB Subcontracting Plan to the email address noted above may result in University's rejection of the proposal as non-responsive due to material failure to comply with advertised specifications; such a proposal may be returned to the Proposer unopened (ref. Section 1.5 of Appendix One to this RFP). Note: The requirement that Proposer provide one (1) completed and signed pdf of the HSP under this Section 2.5.4 is separate from and does not affect Proposer's obligation to provide University with the number of copies of its proposal as specified in Section 3.1 of this RFP.

If Proposer's submitted HSP refers to specific page(s) / Sections(s) of Proposer's proposal that explain how Proposer will perform entire contract with its own equipment, supplies, materials and/or employees, Proposer must submit copies of those pages with the HSP sent to the HSP Submittal email address noted above. Failure to do so will slow the evaluation process and may result in DISQUALIFICATION.

# SUBMISSION OF PROPOSAL

# 3.1 Number of Copies

A. One (1) complete paper copy of its *entire* proposal.

The paper copy of the proposal should contain the mark "original" on the front cover of the proposal. An original signature by an authorized officer of Proposer must appear on the Execution of Offer (ref. Section 2 of APPENDIX ONE) of the submitted paper copy of the proposal.

University does not consider electronic signatures to be valid therefore the original signature must be a "wet signature."

B. One (1) complete electronic copy of its entire proposal in a single .pdf file on USB Flash Drive. USB Flash Drive must include a protective cover and be labeled with Proposer's name and RFP number.

Proposals must be typed on letter-size (8-1/2" x 11") paper, and must be submitted in a 3-ring binder. Preprinted material should be referenced in the proposal and included as labeled attachments. Sections within a proposal should be divided by tabs for ease of reference.

### 3.3 Proposal Validity Period

Each proposal must state that it will remain valid for University's acceptance for a minimum of one hundred and twenty (120) days after the Submittal Deadline, to allow time for evaluation, selection, and any unforeseen delays.

### 3.4 Terms and Conditions

- 3.4.1 Proposer must comply with the requirements and specifications contained in this RFP, including the <u>Agreement</u> (ref. **APPENDIX TWO**), the <u>Notice to Proposer</u> (ref. **Section 2** of this RFP), <u>Proposal Requirements</u> (ref. **APPENDIX ONE**) and the <u>Specifications and Additional Questions</u> (ref. **Section 5** of this RFP). If there is a conflict among the provisions in this RFP, the provision requiring Proposer to supply the better quality or greater quantity of services will prevail, or if such conflict does not involve quality or quantity, then interpretation will be in the following order of precedence:
  - 3.4.1.1. Specifications and Additional Questions (ref. **Section 5** of this RFP);
  - 3.4.1.2. Agreement (ref. **Section 4** and **APPENDIX TWO**);

# **GENERAL TERMS AND CONDITIONS**

The terms and conditions contained in the attached Agreement (ref. **APPENDIX TWO**) or, in the sole discretion of University, terms and conditions substantially similar to those contained in the Agreement, will constitute and govern any agreement that results from this RFP. If Proposer takes exception to any terms or conditions set forth in the Agreement, Proposer will submit redlined **APPENDIX TWO** as part of its proposal in accordance with **Section 5.2.1** of this RFP. Proposer's exceptions will be reviewed by University and may result in disqualification of Proposer's proposal as non-responsive to this RFP. If Proposer's exceptions do not result in disqualification of Proposer's proposal, then University may consider Proposer's exceptions when University evaluates the Proposer's proposal.

# SPECIFICATIONS AND ADDITIONAL QUESTIONS

# 5.1 General

The minimum requirements and the specifications for the Services, as well as certain requests for information to be provided by Proposer as part of its proposal, are set forth below. As indicated in **Section 2.3** of this RFP, the successful Proposer is referred to as the "**Contractor**."

**Contract Term:** University intends to enter into an agreement with the Contractor to perform the Services for an initial three (3) year base term, with the option to renew for two (2) additional one (1) year renewal periods, upon mutual written agreement of both parties.

**Disclosure of Existing Agreement**: University has an existing claims audit service agreement with Wolcott and Associates, Inc., which is scheduled to expire February 28th, 2018.

# 5.2 Additional Questions Specific to this RFP

Proposer must submit the following information as part of Proposer's proposal:

5.2.1 If Proposer takes exception to any terms or conditions set forth in the Agreement (ref. **APPENDIX TWO**), Proposer must redline **APPENDIX TWO** and include **APPENDIX TWO** as part of its Proposal. If Proposer agrees with terms or conditions set forth in the **APPENDIX TWO**, Proposer will submit a written statement acknowledging it.

# 5.3 Scope of Work

This Section describes the scope of the audit services that UT System desires to be conducted for each of the following plans:

- UT SELECT Self-Funded PPO Plan/Indemnity Health Plan;
- UT SELECT Plan Prescription Drug Plan;
- UT DENTAL SELECT Plan.

Third party administrators for these plans may change during the term of the contract.

# 5.3.1 Services Required for the Audits for all three Plans

The audit results of the UT SELECT Self-Funded PPO Plan / Indemnity Health Plan, the UT SELECT Plan Prescription Drug Plan and the UT DENTAL SELECT Plan shall be issued separately. The audit results of all three (3) plans may be combined into one (1) 3-ring binder for convenience of issuance. Tabs separating the UT SELECT Plan from the UT DENTAL SELECT Plan are requested. Each finding, suggestion, and / or recommendation must be easy to reference in the audit report.

One copy of the 3-ring binder with an accompanying Management Letter(s), if applicable, and one (1) electronic copy via email containing the electronic version of the audit reports are to be delivered to the OEB at the conclusion of Contractor's audit services for each plan year.

Recommendations or comments related to internal control, potential plan design or managerial issues and claims administration and adjudication accuracy shall be addressed to the OEB in the Management Letter to be included with the audit results.

Contractor must make an informal (prior to Final Audit Report issuance) presentation of the audit results and Management Letter(s) to the OEB Staff at a date prior to the issuance of the final audit report.

Contractor must follow-up on prior audit recommendations with UT System's Plan administrators as determined by the OEB during field work for the following plan year.

# 5.3.2 <u>Services Required for an Audit of the UT SELECT Self-Funded PPO Plan / Indemnity</u> Health Plan Administrator

Review of the medical claims payments and processing procedures used by **UT System's UT SELECT Plan administrator (currently BCBSTX)** on behalf of persons covered. The scope shall not encompass a review of the financial statements of the plan administrator, nor an audit of its accounting records. The project shall consist of the following:

- A. Review and verification of the accuracy and appropriateness of the annual plan accounting statements. The review and verification must be sufficient to ensure that claims payments, administrative fee payments, the OEB reimbursements and all other information on the reports are accurately reported and charged or related to the appropriate plan years.
- B. Review must be performed of the allowable charge procedures utilized by the plan administrator in the claims payment process to ensure that the allowable amounts are properly developed and updated to reflect the costs of medical care in that plan year.

The review shall also include procedures utilized by the plan administrator on claims that require manual pricing.

For this purpose, a claim will be considered to have been processed if paid or denied or if an information request has been sent to the subscriber or covered dependents ("Claimant(s)") or the treating physician or facility The number of days involved in the processing will be tabulated by counting the number of days between the date received and the date on which the determination is made and adding one (1) day in recognition of the fact that a check or correspondence is unlikely to be mailed until the day after the determination is made.

- C. Review must be performed to verify the financial accuracy of claim payments. The results for network claims should be reported separately from out-of-network claims. The first audit review of BCBSTX claims processed shall be for the time period of September 1, 2016, through August 31, 2017, as follows:
  - 1. Two (2) statistically valid, stratified, random samples of health claims. One (1) sample is to be selected from network health claims, and a second (2) sample is to be selected from non-network and out-of-area health claims. Each sample shall include a significant number of health claims for a total of approximately 500 health claims. Claims shall be selected from all health claims processed during the selected time frame, which shall be deidentified and provided by the OEB to Contractor via FTP and will be PGP-encrypted.
  - 2. The claim samples enumerated above shall be selected using methodology designed to ensure a 95% confidence level with a 1.5% precision rate. Once the samples have been selected, the sample files shall be returned to the OEB so the OEB can populate the de-identified fields with needed Personal Health Information ("PHI") and then returned to Contractor.
- D. In addition to other procedures considered necessary by Contractor to determine accuracy, the claims review process must include the following:
  - 1. Computation of each claim selected for testing to determine its accuracy including analysis of any refunds due and/or payable.
  - Review of the nature of the claim to ascertain the allowable cost as defined in the contract, e.g., processed within the proper allowable amount charge guidelines, medical necessity guidelines, preexisting conditions exclusion, pre-certification requirements and other benefit limitations.
  - 3. Comparison of each claim to supporting documentation submitted by the individual or the provider of services to ensure that the claim reflects the documentation and that it is properly authorized for payment.
  - Comparison of each claim to other claims for that individual with the same dates of service to ensure congruency of payment with all claims for the date of service.
  - 5. Review of the imaged records, microfilm copies and source documents, if available, to see if there is any indication of fraud.
  - 6. Review to ensure the payment is not a duplicate payment.

- 7. Analysis of payment and denial errors by type of error to indicate the error types occurring most frequently and the dollar amounts associated with each error type. Analysis shall distinguish overpayments and erroneous payments from underpayments and erroneous denials and shall address the reasons for the over and underpayments.
- 8. Comparison of the current year audit results to industry norms shall also be made, if the information is available.
- Review to determine if the administrator is following all procedures necessary to obtain a level of Coordination of Benefits ("COB") recoveries consistent with industry standards and the characteristics of the plan's participants.
- 10. Review of the member's specific coverage on the administrator's records compared to the coverage indicated on the OEB records.
- 11. Verification that the claimant is a System employee, retiree or other qualified participant and that the claimant was covered at the time the claim was incurred.
- E. Verify that the processing time from the date an addition, termination, or change of coverage initiated at the institution level to the date it is recorded by the administrator is in accordance performance standards. The time period for the first study shall be from September 1, 2016, through August 31, 2017.
- F. Verify that an adequate system of internal audits and claims processing controls are used by the Administrator to ensure the validity and accuracy of health claims payments.
- G. Review claims processing or other problem areas uncovered as a result of the audit which may warrant further detailed review. This summary shall emphasize areas of claims administration which, if changed or corrected, could result in cost savings to the System. Special emphasis shall be given to this section of the review and should be conducted by an experienced individual.
- H. Verify that an adequate system is used for determining the medical necessity of the claims submitted.
- I. Verify that adequate training procedures are used by the Administrator to ensure that recently hired personnel are adequately trained in claims processing.
- J. Verify that an adequate system is used by the administrator to identify potential areas of claims abuse such as fraudulent claims, duplicate claims, overcharging by providers, unnecessary physician services, etc. The adequacy of the system shall be determined by:
  - 1. Processing the fictitious test data and live transactions and analyzing the processing of the transactions. The tests shall be applied only to health claims.

- Analyzing information about the system of controls, e.g., number of probable fraudulent claims detected, dollar amount of overcharges, length of time between when a claim is processed and when it is identified as potentially fraudulent.
- K. Verify that an adequate system of program edits and claims processing procedures are in place to monitor and discover fraud, erroneous payments, duplicated payments, etc., for individuals who file a large volume of claims which may total several thousand dollars while each individual claim may be relatively small and, therefore, may escape some review processes.
- L. Analyze total amount of overpayments for each plan year by type of overpayment (hospital, provider, member), rate of collection of overpayment by type, total dollar amount of overpayments, total dollar amount of refunds collected, summary of reasons for overpayments, and recommended methods for reducing overpayments.
- M. Analyze administrator's management of the System's grievance appeal process, including the number of grievances which are referred to the administrator's Medical Division for additional review, the number of those referred which result in additional payment, and the percentage of these to the total number of grievance appeals processed.
- N. Verify the reasonableness of information reported on the Administrative Performance Report for the Plan Year.

# 5.3.3 <u>Services Required for an Audit of the UT SELECT Self-Funded Prescription Drug Plan</u> Administrator

The services consist of a review of both the mail order and retail pharmacy network (in and out of network) prescription processing for a combined total of 220 claims (the 20 largest prescriptions filled plus a random sample of 200 others) for the self-funded prescription drug plan. **The plan is currently administered by Express Scripts, Inc.** Claims must be selected from all pharmacy claims processed during the selected timeframe, which must be de-identified and provided by the OEB to Contractor via FTP and will be PGP-encrypted.

The audit of the self-funded prescription drug plan must concentrate on the time of service, dispensing accuracy, claim pricing, billings to the OEB, generic substitutions, Drug Utilization Review ("DUR") and fraud detection / prevention. A statistically valid sample in each of the areas listed must be selected so that the combined samples from all categories will not be less than 220 and will achieve at least a 95% confidence level with a 1.5% precision rate.

The first audit review of pharmacy claims processed must be for the time period of September 1, 2016, through August 31, 2017. Audit reviews must include the following reviews and / or tests:

- A. Initial receipt of prescription or refill requests via mail, Web site, fax or telephone.
- B. Fraud prevention and detection measures.
- C. Use of overrides and address changes.
- D. Accuracy and authenticity of received date.
- E. Accuracy and credibility of imaged or microfilmed records.

- F. Accuracy and effectiveness of backlog controls, processing in order of date received and collated processing of multiple prescriptions for the same person, which are submitted together and/or received by the plan administrator on the same date.
- G. Accuracy and security controls for the posting of co-payments received with prescriptions.
- H. The mail order pharmacy turn-around time as measured from the date the prescription is received to the date the drug is mailed to the plan participant. Contractor must review mail order claims from the facility with the highest percentage of scripts for the System participants for the fiscal year reviewed.
- I. Verify that the plan administrator's pricing accuracy is a function of the plan administrator's use of the most current average wholesale pricing ("AWP") and HCFA "MAC" pricing.
- J. Verify and report that the plan administrator accurately checks the proper copayment is collected at the mail order pharmacy.
- K. Verify that the plan administrator utilizes fraud detection / prevention procedures on the retail pharmacy network claims.
- L. Validating a sample of point-of-sale transactions against the prescription document or by contacting the physician.
- M. Test a sample of refills issued by retail network pharmacies to determine if they were actually requested by the patient.
- N. Testing for validity of prescriptions ordered by telefax. Faxed orders should be from the physician only but can nevertheless be a source of fraud.
- O. Verification that the claimant is a System employee, retiree or other qualified participant and that the claimant was covered at the time the claim was incurred.
- P. Verify the reasonableness of information reported on the PBM Administrative Performance Report for the Plan Year.

# 5.3.4 <u>Services Required for an Audit of the UT Dental SELECT Self-Funded Dental Plan Administrator</u>

Review dental claims payments and processing procedures used by the System's self-funded Dental Plan administrator. The System has two self-funded dental plans-the basic plan and plus plan option. **The current plan administrator of both plans is DELTA DENTAL.** The scope shall not encompass a review of the financial statements of the Dental Plan administrator, nor an audit of its accounting records. However, some review of official records shall be required to ensure that the data used to develop the annual accounting statements are supported by accounting procedures and records. The project shall consist of the following:

- A. Review and verification of the accuracy and appropriateness of the annual accounting statements for Plan Year 2017. Review and verification must be sufficient to ensure that claims payments, administrative fee payments, the OEB reimbursements and all other information reported to the OEB are accurately reported and charged or related to the appropriate fiscal years. Additionally, the review shall determine the appropriateness of refunds to the plan as a result of the administrator's audits of dental office charges negotiated by the administrator.
- B. Review of the allowable charge procedures utilized by the Dental Plan administrator in the claims payment process to ensure that the allowable amounts are properly developed and updated to reflect the costs of dental care. The review must also include procedures utilized by the Dental Plan administrator on claims that require manual pricing. The review of allowable amounts must be for the allowances developed or used during Plan Year 2017.

For this purpose, a claim will be considered to have been processed if paid or denied or if an information request has been sent to the claimant. The number of days involved in the processing will be tabulated by counting the number of days between the date received and the date on which the determination is made and adding one day in recognition of the fact that a check or correspondence is unlikely to be mailed until the day after the determination is made.

- C. Verify the accuracy of claims process and payment. Review and ensure that transitional benefits are paid in accordance with the policies and procedures of the Dental Plan administrator. The first audit review of DELTA DENTAL claims processed shall be the time period from September 1, 2016 through August 31, 2017. Reviews will be conducted as follows:
  - 1. Two (2) statistically valid, stratified, random samples of dental claims. One (1) sample is to be selected from network dental claims, and a second (2) sample is to be selected from non-network and out-of-area dental claims. Each sample shall include a significant number of dental claims for a total of approximately one hundred (100) dental claims. Claims must be selected from all dental claims processed during the selected timeframe, which must be de-identified and provided by the OEB (or plan administrator) to Contractor via FTP and will be PGP-encrypted.
  - 2. The samples enumerated above must be selected using methodology determined in consultation with and approved by the OEB. Samples must be designed to achieve 95% confidence level with a 1.5% precision rate. The stratified random samples of dental claims must be selected based on allocations of the samples to ranges (strata) by claim amount.
- D. In addition to other procedures considered necessary by Contractor to determine accuracy, the claims review process shall include the following:
  - 1. Computation of each claim selected for testing to determine its accuracy.
  - 2. Review of the nature of the claim to ascertain the allowable cost as defined in the contract, e.g., processed within the proper allowable amount charge guidelines, dental necessity guidelines, preexisting conditions exclusion, and other benefit limitations.
  - 3. Comparison of each claim to supporting documentation submitted by the individual or the provider of services to ensure that the claim reflects the documentation and that it is properly authorized for payment.
  - 4. Comparison of each claim to other claims for that individual with the same dates of service to ensure congruency of payment with all claims for the date of service.
  - 5. Review of the imaged records, microfilm copies and source documents, if available, to see if there is any indication of fraud.
  - 6. Review to ensure the payment is not a duplicate payment.
  - 7. Analysis of payment and denial errors by type of error to indicate the error types occurring most frequently and the dollar amounts associated with each error type. Analysis must distinguish overpayments and erroneous

- payments from underpayments and erroneous denials, and shall address the reasons for the over and underpayments.
- 8. Comparison of the current year audit results to industry norms must also be made, if the information is available.
- 9. Review of the member's specific coverage on the administrator's records compared to the coverage indicated on the OEB records.
- 10. Verification that the claimant was a System employee, retiree or other qualified participant and that the claimant was covered at the time the claim was incurred.
- E. Verify that the processing time from the date an addition, termination, or change of coverage initiated at the agency level to the date updated by the plan administrator is recorded in a timely fashion.
- F. Verify that an adequate system of internal audits and claims processing controls is used by the administrator to ensure the validity and contractually correct processing and payment of health claims.
- G. A review of claims processing or other problem areas uncovered as a result of the audit which may warrant further detailed review. This summary must emphasize areas of claims administration which, if changed or corrected, could result in cost savings to the System. Special emphasis shall be given this section of the review and must be conducted by an experienced individual.
- H. Verify that an adequate system is used for determining the dental necessity of the claims submitted.
- I. Verify that adequate training procedures are used by the administrator to ensure that recently hired personnel are adequately trained in claims processing.
- J. Verify that an adequate system is used by the administrator to identify potential areas of claims abuse such as fraudulent claims, duplicate claims, overcharging by providers, unnecessary dental services, etc. The adequacy of the system must be determined by:
  - Processing the fictitious test data and live transactions and analyzing the processing of the transactions. The tests must be applied only to dental claims. Contractor's findings from the tests must be enumerated in an exhibit to the final report.
  - Analyzing information about the system of controls, e.g., number of probable fraudulent claims detected, dollar amount of overcharges, length of time between when a claim is processed and when it is identified as potentially fraudulent.

- K. Verify that an adequate system of program edits and claims processing procedures are in place to monitor and discover fraud, erroneous payments, duplicated payments, etc., for individuals who file a large volume of claims which may total several thousand dollars while each individual claim may be relatively small and, therefore, may escape some review processes.
- L. An analysis of the total amount of overpayments for each Fiscal Year by type of overpayment (provider, member), rate of collection of overpayment by type, total dollar amount of overpayments, total dollar amount of refunds collected, summary of reasons for overpayments, and recommended methods for reducing overpayments.
- M. An analysis of the administrator's management of the grievance appeal process, including the number of grievances which are referred to the administrator for additional review, the number of those referred which result in additional payment, and the percentage of these to the total number of grievance appeals processed.
- N. Verify the reasonableness of information reported on the Administrative Performance Report for the Plan Year.

### **GENERAL INFORMATION**

Proposer also certifies that it understands that all costs relating to preparing a response to this RFP will be the sole responsibility of the Proposer.

PROPOSER IS CAUTIONED TO READ THE INFORMATION CONTAINED IN THIS RFP CAREFULLY AND TO SUBMIT A COMPLETE RESPONSE TO ALL REQUIREMENTS AND QUESTIONS AS DIRECTED.

### 1.2 Inquiries and Interpretations

University may in its sole discretion respond in writing to written inquiries concerning this RFP and mail its response as an Addendum to all parties recorded by University as having received a copy of this RFP. Only University's responses that are made by formal written Addenda will be binding on University. Any verbal responses, written interpretations or clarifications other than Addenda to this RFP will be without legal effect. All Addenda issued by University prior to the Submittal Deadline will be and are hereby incorporated as a part of this RFP for all purposes.

Proposers are required to acknowledge receipt of each Addendum as specified in this Section. The Proposer must acknowledge all Addenda by completing, signing and returning the <u>Addenda Checklist</u> (ref. **Section 4** of **APPENDIX ONE**). The Addenda Checklist must be received by University prior to the Submittal Deadline and should accompany the Proposer's proposal.

### 1.3 Public Information

Proposer is hereby notified that University strictly adheres to all statutes, court decisions and the opinions of the Texas Attorney General with respect to disclosure of public information.

University may seek to protect from disclosure all information submitted in response to this RFP until such time as a final agreement is executed.

Proposer will be advised of a request for public information that implicates their materials and will have the opportunity to raise any objections to disclosure to the Texas Attorney General. ### 1.4 Type of Agreement

Contractor, if any, will be required to enter into a contract with University in a form substantially similar to the Agreement between University and Contractor (the "Agreement") attached to this RFP as APPENDIX TWO and incorporated for all purposes.

### 1.5 Proposal Evaluation Process

University will select Contractor by using the competitive sealed proposal process described in this Section. Any proposals that are not submitted by the Submittal Deadline or that are not accompanied by required number of completed and signed originals of the HSP will be rejected by University as non-responsive due to material failure to comply with this RFP (ref. **Section 2.5.4** of this RFP). Upon completion of the initial review and evaluation of proposals, University may invite one or more selected Proposers to participate in oral presentations. University will use commercially reasonable efforts to avoid public disclosure of the contents of a proposal prior to selection of Contractor.

University may make the selection of Contractor on the basis of the proposals initially submitted, without discussion, clarification or modification. In the alternative, University may make the selection of Contractor on the basis of negotiation with any of the Proposers. In conducting negotiations, University will use commercially reasonable efforts to avoid disclosing the contents of competing proposals.

University may discuss and negotiate all elements of proposals submitted by Proposers within a specified competitive range. - 5.1 University will pay Contractor for the performance of Work in accordance with **Exhibit C**, Payment for Services.
- 5.2 The Contract Amount includes all applicable federal, state or local sales or use taxes payable as a result of the execution or performance of this Agreement.
- University (a State agency) is exempt from Texas Sales & Use Tax on Work in accordance with §151.309, *Texas Tax Code* and 34 *Texas Administrative Code* (TAC) §3.322. Pursuant to 34 TAC §§3.322(c)(4) and (g)(3), this Agreement is sufficient proof of University's tax exempt status and University is not required to provide further evidence of its exempt status.

#### 6. Payment Terms.

- At least ten (10) days before the end of each month during the Term, Contractor will submit to University an invoice covering Work performed for University to that date, in compliance with **Exhibit C**, Payment for Services. Each invoice will be accompanied by documentation that University may reasonably request to support the invoice amount.
- 6.2 Within ten (10) days after final completion and acceptance of Work by University or as soon thereafter as possible, Contractor will submit a final invoice (**Final Invoice**) setting forth all amounts due and remaining unpaid to Contractor. Upon approval of the Final Invoice by University, University will pay (**Final Payment**) to Contractor the amount due under the Final Invoice.
- 6.3 Notwithstanding any provision of this Agreement to the contrary, University will not be obligated to make any payment (whether a Progress Payment or Final Payment) to Contractor if Contractor is in default under this Agreement.
- The cumulative amount of all Progress Payments and the Final Payment (defined below) will not exceed the Contract Amount in **Exhibit C**, Payment for Services.
- No payment made by University will (a) be construed to be final acceptance or approval of that part of the Work to which the payment relates, or (b) relieve Contractor of any of its duties or obligations under this Agreement.
- 6.6 The acceptance of Final Payment by Contractor will constitute a waiver of all claims by Contractor except those previously made in writing and identified by Contractor as unsettled at the time of the Final Invoice for payment.
- 6.7 University will have the right to verify the details in Contractor's invoices and supporting documentation, either before or after payment, by (a) inspecting the books and records of Contractor at mutually convenient times; (b) examining any reports with respect to the Project; and (c) other reasonable action.
- 6.8 Section 51.012, Texas Education Code, authorizes University to make payments through electronic funds transfer methods. Contractor agrees to accept payments from University through those methods, including the automated clearing house system (ACH). Contractor agrees to provide Contractor's banking information to University in writing on Contractor letterhead signed by an authorized representative of Contractor. Prior to the first payment, University will confirm Contractor's banking information. Changes to Contractor's bank information must be communicated to University in accordance with Section 12.14 in writing

at least thirty (30) days before the effective date of the change and must include an <u>IRS Form</u> W-9 signed by an authorized representative of Contractor.

Notwithstanding any other provision of this Agreement, University is entitled to a discount of (Prompt Payment Discount) off of each payment that University submits within days after University's receipt of Contractor's invoice for that payment.

# 7. Ownership and Use of Work Material.

- 7.1 All tools, software, programs, drawings, specifications, plans, computations, sketches, data, photographs, tapes, renderings, models, publications, statements, accounts, reports, studies, and other materials prepared by Contractor or any subcontractors in connection with Work (collectively, **Work Material**), whether or not accepted or rejected by University, are the sole property of University and for its exclusive use and re-use at any time without further compensation and without any restrictions.
- 7.2 Contractor grants and assigns to University all rights and claims of whatever nature and whether now or hereafter arising in and to Work Material and will cooperate fully with University in any steps University may take to obtain or enforce patent, copyright, trademark or like protections with respect to Work Material.
- 7.3 Contractor will deliver all Work Material to University upon expiration or termination of this Agreement. University will have the right to use Work Material for the completion of Work or otherwise. University may, at all times, retain the originals of Work Material. Work Material will not be used by any person other than University on other projects unless expressly authorized by University in writing.
- 7.4 Work Material will not be used or published by Contractor or any other party unless expressly authorized by University in writing. Contractor will treat all Work Material as confidential.
- All title and interest in Work Material will vest in University and will be deemed to be work made for hire and made in the course of Work rendered under this Agreement. To the extent that title to any Work Material may not, by operation of law, vest in University or Work Material may not be considered works made for hire, Contractor irrevocably assigns, conveys and transfers to University and its successors, licensees and assigns, all rights, title and interest worldwide in and to Work Material and all proprietary rights therein, including all copyrights, trademarks, service marks, patents, trade secrets, moral rights, all contract and licensing rights and all claims and causes of action with respect to any of the foregoing, whether now known or hereafter to become known. In the event Contractor has any rights in Work Material which cannot be assigned, Contractor agrees to waive enforcement worldwide of the rights against University, its successors, licensees, assigns, distributors and customers or, if necessary, to exclusively license the rights, worldwide to University with the right to sublicense. These rights are assignable by University.

## 8. <u>Default and Termination</u>

- 8.1 In the event of a material failure by a party to this Agreement to perform in accordance with its terms (**default**), the other party may terminate this Agreement upon fifteen (15) days' written notice of termination setting forth the nature of the material failure; <u>provided</u>, <u>that</u>, the material failure is through no fault of the terminating party. The termination will not be effective if the material failure is fully cured prior to the end of the fifteen-day (15)-day period.
- 8.2 University may, without cause, terminate this Agreement at any time upon giving seven (7) days' advance written notice to Contractor. Upon termination pursuant to this Section, Contractor will be entitled to payment of an amount that will compensate Contractor for Work

satisfactorily performed from the time of the last payment date to the termination date in accordance with this Agreement; <u>provided</u>, <u>that</u>, Contractor has delivered all Work Material to University. Notwithstanding any provision in this Agreement to the contrary, University will not be required to pay or reimburse Contractor for any services performed or for expenses incurred by Contractor after the date of the termination notice, that could have been avoided or mitigated by Contractor.

- 8.3 Termination under **Sections 8.1** or **8.2** will not relieve Contractor from liability for any default or breach under this Agreement or any other act or omission of Contractor.
- 8.4 If Contractor fails to cure any default within fifteen (15) days after receiving written notice of the default, University will be entitled (but will not be obligated) to cure the default and will have the right to offset against all amounts due to Contractor under this Agreement, any and all reasonable expenses incurred in connection with University's curative actions.

#### 9. Indemnification

- 9.1 TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAWS, CONTRACTOR WILL AND DOES HEREBY AGREE TO INDEMNIFY, PROTECT, DEFEND WITH COUNSEL APPROVED BY UNIVERSITY, AND HOLD HARMLESS UNIVERSITY RESPECTIVE AFFILIATED ENTERPRISES, REGENTS, OFFICERS, DIRECTORS, ATTORNEYS, EMPLOYEES, REPRESENTATIVES AND AGENTS (COLLECTIVELY, INDEMNITEES) FROM AND AGAINST ALL DAMAGES, LOSSES, LIENS, CAUSES OF ACTION, SUITS, JUDGMENTS, EXPENSES, AND OTHER CLAIMS OF ANY NATURE, KIND, OR DESCRIPTION, INCLUDING REASONABLE ATTORNEYS' FEES INCURRED IN INVESTIGATING, DEFENDING OR SETTLING ANY OF THE FOREGOING (COLLECTIVELY, CLAIMS) BY ANY PERSON OR ENTITY, ARISING OUT OF, CAUSED BY, OR RESULTING FROM CONTRACTOR'S PERFORMANCE UNDER OR BREACH OF THIS AGREEMENT AND THAT ARE CAUSED IN WHOLE OR IN PART BY ANY NEGLIGENT ACT, NEGLIGENT OMISSION OR WILLFUL MISCONDUCT OF CONTRACTOR, ANYONE DIRECTLY EMPLOYED BY CONTRACTOR OR ANYONE FOR WHOSE ACTS CONTRACTOR MAY BE LIABLE. THE PROVISIONS OF THIS SECTION WILL NOT BE CONSTRUED TO ELIMINATE OR REDUCE ANY OTHER INDEMNIFICATION OR RIGHT WHICH ANY INDEMNITEE HAS BY LAW OR EQUITY. ALL PARTIES WILL BE ENTITLED TO BE REPRESENTED BY COUNSEL AT THEIR OWN EXPENSE.
- 9.2 IN ADDITION, CONTRACTOR WILL AND DOES HEREBY AGREE TO INDEMNIFY, PROTECT, DEFEND WITH COUNSEL APPROVED BY UNIVERSITY, AND HOLD HARMLESS INDEMNITEES FROM AND AGAINST ALL CLAIMS ARISING FROM INFRINGEMENT OR ALLEGED INFRINGEMENT OF ANY PATENT, COPYRIGHT, TRADEMARK OR OTHER PROPRIETARY INTEREST ARISING BY OR OUT OF THE PERFORMANCE OF SERVICES OR THE PROVISION OF GOODS BY CONTRACTOR, OR THE USE BY INDEMNITEES, AT THE DIRECTION OF CONTRACTOR, OF ANY ARTICLE OR MATERIAL; PROVIDED, THAT, UPON BECOMING AWARE OF A SUIT OR THREAT OF SUIT FOR INFRINGEMENT, UNIVERSITY WILL PROMPTLY NOTIFY CONTRACTOR AND CONTRACTOR WILL BE GIVEN THE OPPORTUNITY TO NEGOTIATE A SETTLEMENT. IN THE EVENT OF LITIGATION, UNIVERSITY AGREES TO REASONABLY COOPERATE WITH CONTRACTOR. ALL PARTIES WILL BE ENTITLED TO BE REPRESENTED BY COUNSEL AT THEIR OWN EXPENSE.

### 10. Relationship of the Parties.

For all purposes of this Agreement and notwithstanding any provision of this Agreement to the contrary, Contractor is an independent contractor and is not a state employee, partner, joint venturer, or agent of University. Contractor will not bind nor attempt to bind University to any agreement or contract. As an independent contractor, Contractor is solely responsible for all taxes, withholdings, and other statutory or contractual obligations of any sort, including workers' compensation insurance.

## 11. <u>Insurance</u>.

- 11.1 Contractor, consistent with its status as an independent contractor will carry and will cause its subcontractors to carry, at least the following insurance, with companies authorized to do insurance business in the State of Texas or eligible surplus lines insurers operating in accordance with the <a href="Texas Insurance Code">Texas Insurance Code</a>, having an A.M. Best Rating of A-:VII or better, and in amounts not less than the following minimum limits of coverage:
  - 11.1.1 Workers' Compensation Insurance with statutory limits, and Employer's Liability Insurance with limits of not less than \$1,000,000:

Employers Liability - Each Accident	\$1,000,000
Employers Liability - Each Employee	\$1,000,000
Employers Liability - Policy Limit	\$1,000,000

Workers' Compensation policy must include under Item 3.A. of the information page of the Workers' Compensation policy the state in which Work is to be performed for University.

11.1.2 Commercial General Liability Insurance with limits of not less than:

\$1,000,000
\$2,000,000
\$2,000,000

The required Commercial General Liability policy will be issued on a form that insures Contractor's and subcontractor's liability for bodily injury (including death), property damage, personal, and advertising injury assumed under the terms of this Agreement.

- 11.1.3 Business Auto Liability Insurance covering all owned, non-owned or hired automobiles, with limits of not less than \$1,000,000 single limit of liability per accident for Bodily Injury and Property Damage;
- 11.1.4 Professional Liability (Errors & Omissions) Insurance with limits of not less than \$1,000,000 each occurrence, \$3,000,000 aggregate. Such insurance will cover all Work performed by or on behalf of Contractor and its subcontractors under this Agreement. Renewal policies written on a claims-made basis will maintain the same retroactive date as in effect at the inception of this Agreement. If coverage is written on a claims-made basis, Contractor agrees to purchase an Extended Reporting Period Endorsement, effective twenty-four (24) months after the expiration or cancellation of the policy. No Professional Liability policy written on an occurrence form will include a sunset or similar clause that limits coverage unless such clause provides coverage for at least thirty-six (36) months after the expiration or termination of this Agreement for any reason.
- 11.1.5 Contractor's Employee Dishonesty Insurance will be endorsed with a *Client's Property Endorsement* (or equivalent) to protect the assets and property of University with limits of not less than \$1,000,000 per claim. If Contractor has property of University in its care, custody or control away from University's premises, Contractor will provide bailee coverage for the replacement cost of the

property. Contractor's Employee Dishonesty policy will name University as Loss Pavee.

- 11.2 Contractor will deliver to University:
  - 11.2.1 After the execution and delivery of this Agreement and prior to the performance of any Work by Contractor, evidence of insurance on a Texas Department of Insurance (**TDI**) approved certificate form (the Acord form is a TDI-approved form) verifying the existence and actual limits of all required insurance policies; and, if the coverage period shown on the current certificate form ends during the Term, then prior to the end of the coverage period, a new certificate form verifying the continued existence of all required insurance policies.
    - 11.2.1.1 All insurance policies (with the exception of workers' compensation, employer's liability and professional liability) will be endorsed and name the Board of Regents of The University of Texas System, and University as Additional Insureds for liability caused in whole or in part by Contractor's acts or omissions with respect to its on-going and completed operations up to the actual liability limits of the required insurance policies maintained by Contractor. Commercial General Liability Additional Insured endorsement including ongoing and completed operations coverage will be submitted with the Certificates of Insurance. Commercial General Liability and Business Auto Liability will be endorsed to provide primary and non-contributory coverage.
    - 11.2.1.2 Contractor hereby waives all rights of subrogation against the Board of Regents of The University of Texas System, and University. <u>All insurance policies</u> will be endorsed to provide a waiver of subrogation in favor of the Board of Regents of The University of Texas System and University. No policy will be canceled until after thirty (30) days' unconditional written notice to University. <u>All insurance policies</u> will be endorsed to require the insurance carrier providing coverage to send notice to University thirty (30) days prior to any cancellation, material change, or non-renewal relating to any insurance policy required in this Section 11.
    - 11.2.1.3 Contractor will pay any deductible or self-insured retention for any loss. Any self-insured retention must be declared to and approved by University prior to the performance of any Work by Contractor under this Agreement. All deductibles and self-insured retentions will be shown on the Certificates of Insurance.
    - 11.2.1.4 Certificates of Insurance and *Additional Insured Endorsements* as required by this Agreement will be mailed, faxed, or emailed to the following University contact:

- 11.3 Contractor's or subcontractor's insurance will be primary to any insurance carried or self-insurance program established by University. Contractor's or subcontractor's insurance will be kept in force until all Work has been fully performed and accepted by University in writing.
  - 11.3.1 Professional Liability Insurance coverage written on a claims-made basis requires Contractor to purchase an *Extended Reporting Period Endorsement*, effective for thirty-six (36) months after the expiration or cancellation of the policy.

## 12. Miscellaneous.

- 12.1 Assignment and Subcontracting. Except as specifically provided in <u>Exhibit E</u>, Historically Underutilized Business Subcontracting Plan, Contractor's interest in this Agreement (including Contractor's duties and obligations under this Agreement, and the fees due to Contractor under this Agreement) may not be subcontracted, assigned, delegated, or otherwise transferred to a third party, in whole or in part, and any attempt to do so will (a) not be binding on University; and (b) be a breach of this Agreement for which Contractor will be subject to all remedial actions provided by Applicable Laws, including <u>Chapter 2161</u>, <u>Texas Government Code</u>, and <u>34 TAC §§20.285(g)(5)</u>, <u>20.585 and 20.586</u>. The benefits and burdens of this Agreement are assignable by University.
- 12.2 **Texas Family Code Child Support Certification**. Pursuant to §231.006, Texas Family Code, Contractor certifies it is not ineligible to receive the award of or payments under this Agreement, and acknowledges this Agreement may be terminated and payment withheld if this certification is inaccurate.
- 12.3 **Tax Certification.** If Contractor is a taxable entity as defined by <u>Chapter 171, Texas Tax Code</u>, then Contractor certifies it is not currently delinquent in the payment of any taxes due under Chapter 171, Contractor is exempt from the payment of those taxes, or Contractor is an out-of-state taxable entity that is not subject to those taxes, whichever is applicable.
- Payment of Debt or Delinquency to the State. Pursuant to §§2107.008 and 2252.903, Texas Government Code, Contractor agrees any payments owing to Contractor under this Agreement may be applied directly toward any debt or delinquency Contractor owes the State of Texas or any agency of the State of Texas, regardless of when it arises, until paid in full.
- Loss of Funding. Performance by University under this Agreement may be dependent upon the appropriation and allotment of funds by the Texas State Legislature (Legislature) and/or allocation of funds by the Board of Regents of The University of Texas System (Board). If Legislature fails to appropriate or allot necessary funds, or Board fails to allocate necessary funds, then University will issue written notice to Contractor and University may terminate this Agreement without further duty or obligation. Contractor acknowledges that appropriation, allotment, and allocation of funds are beyond University's control.
- 12.6 **Entire Agreement; Modifications.** This Agreement (including all exhibits, schedules, supplements and other attachments (collectively, **Exhibits**)) supersedes all prior agreements, written or oral, between Contractor and University and will constitute the entire Agreement and understanding between the parties with respect to its subject matter. This Agreement and each of its provisions will be binding upon the parties, and may not be waived, modified, amended or altered, except by a writing signed by University and Contractor. All Exhibits are attached to this Agreement and incorporated for all purposes.

- 12.7 **Force Majeure.** Neither party hereto will be liable or responsible to the other for any loss or damage or for any delays or failure to perform due to causes beyond its reasonable control including acts of God, strikes, epidemics, war, riots, flood, fire, sabotage, or any other circumstances of like character (**force majeure occurrence**). <u>Provided, however</u>, in the event of a force majeure occurrence, Contractor agrees to use its best efforts to mitigate the impact of the occurrence so that University may continue to provide mission critical services during the occurrence.
- 12.8 **Captions.** The captions of sections and subsections in this Agreement are for convenience only and will not be considered or referred to in resolving questions of interpretation or construction.
- 12.9 **Venue; Governing Law.** Travis County, Texas, will be the proper place of venue for suit on or in respect of this Agreement. This Agreement, all of its terms and conditions, all rights and obligations of its parties, and all claims arising out of or relating to the Agreement, will be construed, interpreted and applied in accordance with, governed by and enforced under, the laws of the State of Texas.
- 12.10 Waivers. No delay or omission in exercising any right accruing upon a default in performance of this Agreement will impair any right or be construed to be a waiver of any right. A waiver of any default under this Agreement will not be construed to be a waiver of any subsequent default under this Agreement.
- 12.11 Confidentiality and Safeguarding of University Records; Press Releases; Public Information. Under this Agreement, Contractor may (1) create, (2) receive from or on behalf of University, or (3) have access to, records or record systems (collectively, University Records). Among other things, University Records may contain social security numbers, credit card numbers, or data protected or made confidential or sensitive by Applicable Laws. Additional mandatory confidentiality and security compliance requirements with respect to University Records subject to the Health Insurance Portability and Accountability Act and 45 Code of Federal Regulations (CFR) Part 160 and subparts A and E of Part 164 (collectively, HIPAA) are addressed in Section 12.25. Contractor represents, warrants, and agrees that it will: (1) hold University Records in strict confidence and will not use or disclose University Records except as (a) permitted or required by this Agreement, (b) required by Applicable Laws, or (c) otherwise authorized by University in writing; (2) safeguard University Records according to reasonable administrative, physical and technical standards (such as standards established by the National Institute of Standards and Technology and the Center for Internet Security, as well as the Payment Card Industry Data Security Standards) that are no less rigorous than the standards by which Contractor protects its own confidential information; (3) continually monitor its operations and take any action necessary to assure that University Records are safeguarded and the confidentiality of University Records is maintained in accordance with all Applicable Laws and the terms of this Agreement; and (4) comply with University Rules regarding access to and use of University's computer systems, including UTS165 at http://www.utsystem.edu/board-of-regents/policy-library/policies/uts165-informationresources-use-and-security-policy. At the request of University, Contractor agrees to provide University with a written summary of the procedures Contractor uses to safeguard and maintain the confidentiality of University Records.
  - 12.11.1 **Notice of Impermissible Use.** If an impermissible use or disclosure of any University Records occurs, Contractor will provide written notice to University within one (1) business day after Contractor's discovery of that use or disclosure. Contractor will promptly provide University with all information requested by University regarding the impermissible use or disclosure.

- 12.11.2 **Return of University Records.** Contractor agrees that within thirty (30) days after the expiration or termination of this Agreement, for any reason, all University Records created or received from or on behalf of University will be (1) returned to University, with no copies retained by Contractor; or (2) if return is not feasible, destroyed. Twenty (20) days before destruction of any University Records, Contractor will provide University with written notice of Contractor's intent to destroy University Records. Within five (5) days after destruction, Contractor will confirm to University in writing the destruction of University Records.
- 12.11.3 **Disclosure.** If Contractor discloses any University Records to a subcontractor or agent, Contractor will require the subcontractor or agent to comply with the same restrictions and obligations as are imposed on Contractor by this **Section 12.11**.
- 12.11.4 Press Releases. Except when defined as part of Work, Contractor will not make any press releases, public statements, or advertisement referring to the Project or the engagement of Contractor as an independent contractor of University in connection with the Project, or release any information relative to the Project for publication, advertisement or any other purpose without the prior written approval of University.
- 12.11.5 **Public Information.** University strictly adheres to all statutes, court decisions and the opinions of the Texas Attorney General with respect to disclosure of public information under the *Texas Public Information Act* (**TPIA**), <u>Chapter 552</u>, <u>Texas Government Code</u>. In accordance with §§552.002 and 2252.907, <u>Texas Government Code</u>, and at no additional charge to University, Contractor will make any information created or exchanged with University pursuant to this Agreement (and not otherwise exempt from disclosure under TPIA) available in a format reasonably requested by University that is accessible by the public.
- 12.11.6 **Termination.** In addition to any other termination rights in this Agreement and any other rights at law or equity, if University reasonably determines that Contractor has breached any of the restrictions or obligations in this Section, University may immediately terminate this Agreement without notice or opportunity to cure.
- 12.11.7 **Duration.** The restrictions and obligations under this Section will survive expiration or termination of this Agreement for any reason.
- 12.12 **Binding Effect.** This Agreement will be binding upon and inure to the benefit of the parties hereto and their respective permitted assigns and successors.
- 12.13 **Records.** Records of Contractor's costs, reimbursable expenses pertaining to the Project and payments will be available to University or its authorized representative during business hours and will be retained for four (4) years after final Payment or abandonment of the Project, unless University otherwise instructs Contractor in writing.
- 12.14 Notices. Except as otherwise provided by this Section, notices, consents, approvals, demands, requests or other communications required or permitted under this Agreement, will be in writing and sent via certified mail, hand delivery, overnight courier, facsimile transmission (to the extent a facsimile number is provided below), or email (to the extent an email address is provided below) as indicated below, and notice will be deemed given (i) if delivered by certified mailed, when deposited, postage prepaid, in the United States mail, or (ii) if delivered by hand, overnight courier, facsimile (to the extent a facsimile number is provided below) or email (to the extent an email address is provided below), when received:

- 12.15 **Severability.** In case any provision of this Agreement will, for any reason, be held invalid or unenforceable in any respect, the invalidity or unenforceability will not affect any other provision of this Agreement, and this Agreement will be construed as if the invalid or unenforceable provision had not been included.
- 12.16 **State Auditor's Office.** Contractor understands acceptance of funds under this Agreement constitutes acceptance of authority of the Texas State Auditor's Office or any successor agency (**Auditor**), to conduct an audit or investigation in connection with those funds (ref. §§51.9335(c), 73.115(c) and 74.008(c), Texas Education Code). Contractor agrees to cooperate with Auditor in the conduct of the audit or investigation, including providing all records requested. Contractor will include this provision in all contracts with permitted subcontractors.
- 12.17 Limitation of Liability. Except for University's obligation (IF any) to pay Contractor certain fees and expenses University will have no liability to Contractor or to anyone claiming through or under Contractor by reason of the execution or performance of this Agreement. Notwithstanding any duty or obligation of University to Contractor or to anyone claiming through or under Contractor, no present or future affiliated enterprise, subcontractor, agent, officer, director, employee, representative, attorney or regent of University, or the University of Texas System, or anyone claiming under University has or will have any personal liability to Contractor or to anyone claiming through or under Contractor by reason of the execution or performance of this Agreement.
- 12.18 **Survival of Provisions.** No expiration or termination of this Agreement will relieve either party of any obligations under this Agreement that by their nature survive expiration or termination, including **Sections 6.7**, **9**, **12.5**, **12.9**, **12.10**, **12.11**, **12.13**, **12.16**, **12.17**, **12.19** and **12.21**.

- 12.19 **Breach of Contract Claims.** To the extent that <u>Chapter 2260</u>, <u>Texas Government Code</u>, as it may be amended from time to time (**Chapter 2260**), is applicable to this Agreement and is not preempted by other Applicable Laws, the dispute resolution process provided for in <u>Chapter 2260</u> will be used, as further described herein, by University and Contractor to attempt to resolve any claim for breach of contract made by Contractor:
  - 12.19.1.1 Contractor's claims for breach of this Agreement that the parties cannot resolve pursuant to other provisions of this Agreement or in the ordinary course of business will be submitted to the negotiation process provided in subchapter B of Chapter 2260. To initiate the process, Contractor will submit written notice, as required by subchapter B of Chapter 2260, to University in accordance with the notice provisions in this Agreement. Contractor's notice will specifically state that the provisions of subchapter B of Chapter 2260 are being invoked, the date and nature of the event giving rise to the claim, the specific contract provision that University allegedly breached, the amount of damages Contractor seeks, and the method used to calculate the damages. Compliance by Contractor with subchapter B of Chapter 2260 is a required prerequisite to Contractor's filing of a contested case proceeding under subchapter C of Chapter 2260. The chief business officer of University, or another officer of University as may be designated from time to time by University by written notice to Contractor in accordance with the notice provisions in this Agreement, will examine Contractor's claim and any counterclaim and negotiate with Contractor in an effort to resolve the claims.
  - 12.19.1.2 If the parties are unable to resolve their disputes under Section 12.19.1.1, the contested case process provided in subchapter C of Chapter 2260 is Contractor's sole and exclusive process for seeking a remedy for any and all of Contractor's claims for breach of this Agreement by University.
  - 12.19.1.3 Compliance with the contested case process provided in <a href="subchapter C">subchapter C</a> of Chapter 2260 is a required prerequisite to seeking consent to sue from the Legislature under <a href="Chapter 107">Chapter 107</a>, <a href="Texas Civil Practices and Remedies Code">Texas Civil Practices and Remedies Code</a>. The parties hereto specifically agree that (i) neither the execution of this Agreement by University nor any other conduct, action or inaction of any representative of University relating to this Agreement constitutes or is intended to constitute a waiver of University's or the state's sovereign immunity to suit and (ii) University has not waived its right to seek redress in the courts.
  - 12.19.2 The submission, processing and resolution of Contractor's claim is governed by the published rules adopted by the Texas Attorney General pursuant to <a href="Chapter 2260">Chapter 2260</a>, as currently effective, thereafter enacted or subsequently amended.
  - 12.19.3 University and Contractor agree that any periods provided in this Agreement for notice and cure of defaults are not waived.
- 12.20 **Undocumented Workers.** The *Immigration and Nationality Act* (8 USC §1324a) (**Immigration Act**) makes it unlawful for an employer to hire or continue employment of

undocumented workers. The United States Immigration and Customs Enforcement Service has established the Form I-9 Employment Eligibility Verification Form (I-9 Form) as the document to be used for employment eligibility verification (8 CFR §274a). Among other things, Contractor is required to: (1) have all employees complete and sign the I-9 Form certifying that they are eligible for employment: (2) examine verification documents required by the I-9 Form to be presented by the employee and ensure the documents appear to be genuine and related to the individual; (3) record information about the documents on the I-9 Form, and complete the certification portion of the I-9 Form; and (4) retain the I-9 Form as required by Applicable Laws. It is illegal to discriminate against any individual (other than a citizen of another country who is not authorized to work in the United States) in hiring, discharging, or recruiting because of that individual's national origin or citizenship status. If Contractor employs unauthorized workers during performance of this Agreement in violation of the Immigration Act then, in addition to other remedies or penalties prescribed by Applicable Laws, University may terminate this Agreement in accordance with Section 8. Contractor represents and warrants that it is in compliance with and agrees that it will remain in compliance with the provisions of the Immigration Act.

- 12.21 **Limitations.** The Parties are aware there are constitutional and statutory limitations (**Limitations**) on the authority of University (a state agency) to enter into certain terms and conditions that may be part of this Agreement, including terms and conditions relating to liens on University's property; disclaimers and limitations of warranties; disclaimers and limitations of liability for damages; waivers, disclaimers and limitations of legal rights, remedies, requirements and processes; limitations of periods to bring legal action; granting control of litigation or settlement to another party; liability for acts or omissions of third parties; payment of attorneys' fees; dispute resolution; indemnities; and confidentiality, and terms and conditions related to Limitations will not be binding on University except to the extent authorized by the laws and Constitution of the State of Texas.
- 12.22 Ethics Matters; No Financial Interest. Contractor and its employees, agents, representatives and subcontractors have read and understand University's Conflicts of Interest Policy at <a href="http://www.utsystem.edu/board-of-regents/policy-library/policies/int180-conflicts-interest-conflicts-commitment-and-outside-]">http://www.utsystem.edu/board-of-regents/policy-library/policies/int180-conflicts-interest-conflicts-commitment-and-outside-]</a>, University's Standards of Conduct Guide at <a href="https://www.utsystem.edu/documents/docs/policies-rules/ut-system-administration-standards-conduct-guide]</a>, and applicable state ethics laws and rules at <a href="http://utsystem.edu/offices/general-counsel/ethics">https://utsystem.edu/offices/general-counsel/ethics</a>. Neither Contractor nor its employees, agents, representatives or subcontractors will assist or cause University employees to violate University's Conflicts of Interest Policy, University's Standards of Conduct Guide, or applicable state ethics laws or rules. Contractor represents and warrants that no member of the Board has a direct or indirect financial interest in the transaction that is the subject of this Agreement.

#### 12.23 **INTENTIONALLY OMITTED**

12.24 **Enforcement.** Contractor agrees and acknowledges that University is entering into this Agreement in reliance on Contractor's special and unique knowledge and abilities with respect to performing Work. Contractor's services provide a peculiar value to University. University cannot be reasonably or adequately compensated in damages for the loss of Contractor's services. Accordingly, Contractor acknowledges and agrees that a breach by Contractor of the provisions of this Agreement will cause University irreparable injury and damage. Contractor, therefore, expressly agrees that University will be entitled to injunctive and/or other equitable relief in any court of competent jurisdiction to prevent or otherwise restrain a breach of this Agreement.

- 12.25 **HIPAA Compliance.** University is a HIPAA Covered Entity and some of the information Contractor receives, maintains or creates for or on behalf of University may constitute Protected Health Information (**PHI**) that is subject to HIPAA. Before Contractor may receive, maintain or create any University Records subject to HIPAA, Contractor will execute the HIPAA Business Associate Agreement (**BAA**) in **EXHIBIT D**, HIPAA Business Associate Agreement. To the extent that the BAA conflicts with any term contained in this Agreement, the terms of the BAA will control.
- 12.26 Subcontracting. Contractor will use good faith efforts to subcontract work performed under this Agreement in accordance with the Historically Underutilized Business Subcontracting Plan (HSP) (ref. Exhibit E). Except as specifically provided in the HSP, Contractor will not subcontract any of its duties or obligations under this Agreement, in whole or in part. This Agreement is subject to 34 TAC §20.285. Contractor will comply with all of its duties and obligations under 34 TAC §20.285. In addition to other rights and remedies, University may exercise all rights and remedies authorized by 34 TAC §20.285.

Historically Underutilized Business Subcontracting Plan. Contractor agrees to use good faith efforts to subcontract Work in accordance with the Historically Underutilized Business Subcontracting Plan (HSP) (ref. <a href="Exhibit E">Exhibit E</a>). Contractor agrees to maintain business records documenting its compliance with the HSP and to submit a monthly compliance report to University in the format required by the Statewide Procurement and Statewide Support Services Division of the Texas Comptroller of Public Accounts or successor entity (collectively, SPSS). Submission of compliance reports will be required as a condition for payment under this Agreement. If University determines that Contractor has failed to subcontract as set out in the HSP, University will notify Contractor of any deficiencies and give Contractor an opportunity to submit documentation and explain why the failure to comply with the HSP should not be attributed to a lack of good faith effort by Contractor. If University determines that Contractor failed to implement the HSP in good faith, University, in addition to any other remedies, may report nonperformance to the SPSS in accordance with \_34 TAC \$\square\$20.285(g)(5), 20.585 and 20.586. University may also revoke this Agreement for breach and make a claim against Contractor.

- 12.26.1 **Changes to the HSP.** If at any time during the Term, Contractor desires to change the HSP, before the proposed changes become effective (a) Contractor must comply with 34 TAC §20.285; (b) the changes must be reviewed and approved by University; and (c) if University approves changes to the HSP, this Agreement must be amended in accordance with **Section 12.6** to replace the HSP with the revised subcontracting plan.
- 12.26.2 **Expansion of Work.** If University expands the scope of Work through a change order or any other amendment, University will determine if the additional Work contains probable subcontracting opportunities *not* identified in the initial solicitation for Work. If University determines additional probable subcontracting opportunities exist, Contractor will submit an amended subcontracting plan covering those opportunities. The amended subcontracting plan must comply with the provisions of 34 TAC §20.285 before (a) this Agreement may be amended to include the additional Work; or (b) Contractor may perform the additional Work. If Contractor subcontracts any of the additional subcontracting opportunities identified by University without prior authorization and without complying with 34 TAC §20.285, Contractor will be deemed to be in breach of this Agreement under **Section 8** and will be subject to any remedial actions provided by Applicable Laws, including Chapter 2161, *Texas Government Code*, and 34 TAC §20.285. University may report nonperformance under this Agreement to the SPSS in accordance with 34 TAC §\$20.285(g)(5), 20.585 and 20.586.

12.27 Responsibility for Individuals Performing Work; Criminal Background Checks. Each individual who is assigned to perform Work under this Agreement will be an employee of Contractor or an employee of a subcontractor engaged by Contractor. Contractor is responsible for the performance of all individuals performing Work under this Agreement. Prior to commencing Work, Contractor will (1) provide University with a list (List) of all individuals who may be assigned to perform Work on University's premises and (2) have an appropriate criminal background screening performed on all the individuals on the List. Contractor will determine on a case-by-case basis whether each individual assigned to perform Work is qualified to provide the services. Contractor will not knowingly assign any individual to provide services on University's premises who has a history of criminal conduct unacceptable for a university campus or healthcare center, including violent or sexual offenses. Contractor will update the List each time there is a change in the individuals assigned to perform Work on University's premises.

Prior to commencing performance of Work under this Agreement, Contractor will provide University a letter signed by an authorized representative of Contractor certifying compliance with this Section. Contractor will provide University an updated certification letter each time there is a change in the individuals on the List.

- 12.28 **Contractor Certification regarding Boycotting Israel.** Pursuant to Chapter 2270, *Texas Government Code*, Contractor certifies Contractor (1) does not currently boycott Israel; and (b) will not boycott Israel during the Term of this Agreement. Contractor acknowledges this Agreement may be terminated and payment withheld if this certification is inaccurate.
- 12.29 Contractor Certification regarding Business with Certain Countries and Organizations. Pursuant to Subchapter F, Chapter 2252, Texas Government Code, Contractor certifies Contractor (1) is not engaged in business with Iran, Sudan, or a foreign terrorist organization. Contractor acknowledges this Agreement may be terminated and payment withheld if this certification is inaccurate.

University and Contractor have executed and delivered this Agreement to be effective as of the Effective Date.

# **EXHIBIT A**

#### SCOPE OF WORK

This Section describes the scope of the audit services that UT System desires to be conducted for each of the following plans:

This Section describes the scope of the audit services that UT System desires to be conducted for each of the following plans:

- UT SELECT Self-Funded PPO Plan/Indemnity Health Plan;
- UT SELECT Plan Prescription Drug Plan;
- UT DENTAL SELECT Plan.

Third party administrators for these plans may change during the term of the contract.

# 1 Services Required for the Audits for all three Plans

The audit results of the UT SELECT Self-Funded PPO Plan / Indemnity Health Plan, the UT SELECT Plan Prescription Drug Plan and the UT DENTAL SELECT Plan shall be issued separately. The audit results of all three (3) plans may be combined into one (1) 3-ring binder for convenience of issuance. Tabs separating the UT SELECT Plan from the UT DENTAL SELECT Plan are requested. Each finding, suggestion, and / or recommendation must be easy to reference in the audit report.

One copy of the 3-ring binder with an accompanying Management Letter(s), if applicable, and one (1) electronic copy via email containing the electronic version of the audit reports are to be delivered to the OEB at the conclusion of Contractor's audit services for each plan year.

Recommendations or comments related to internal control, potential plan design or managerial issues and claims administration and adjudication accuracy shall be addressed to the OEB in the Management Letter to be included with the audit results.

Contractor must make an informal (prior to Final Audit Report issuance) presentation of the audit results and Management Letter(s) to the OEB Staff at a date prior to the issuance of the final audit report.

Contractor must follow-up on prior audit recommendations with UT System's Plan administrators as determined by the OEB during field work for the following plan year.

# 2 Services Required for an Audit of the UT SELECT Self-Funded PPO Plan / Indemnity Health Plan Administrator

Review of the medical claims payments and processing procedures used by **UT System's UT SELECT Plan administrator (currently BCBSTX)** on behalf of persons covered. The scope shall not encompass a review of the financial statements of the plan administrator, nor an audit of its accounting records. The project shall consist of the following:

- A. Review and verification of the accuracy and appropriateness of the annual plan accounting statements. The review and verification must be sufficient to ensure that claims payments, administrative fee payments, the OEB reimbursements and all other information on the reports are accurately reported and charged or related to the appropriate plan years.
- B. Review must be performed of the allowable charge procedures utilized by the plan administrator in the claims payment process to ensure that the allowable amounts are properly developed and updated to reflect the costs of medical care in that plan year. The review shall also include procedures utilized by the plan administrator on claims that require manual pricing.

For this purpose, a claim will be considered to have been processed if paid or denied or if an information request has been sent to the subscriber or covered dependents ("Claimant(s)") or the treating physician or facility The number of days involved in the processing will be tabulated by counting the number of days between the date received and the date on which the determination is made and adding one (1) day in recognition of the fact that a check or correspondence is unlikely to be mailed until the day after the determination is made.

- C. Review must be performed to verify the financial accuracy of claim payments. The results for network claims should be reported separately from out-of-network claims. The first audit review of BCBSTX claims processed shall be for the time period of September 1, 2016, through August 31, 2017, as follows:
  - Two (2) statistically valid, stratified, random samples of health claims. One (1) sample is to be selected from network health claims, and a second (2) sample is to be selected from nonnetwork and out-of-area health claims. Each sample shall include a significant number of health claims for a total of approximately 500 health claims. Claims shall be selected from all health claims processed during the selected time

- frame, which shall be de-identified and provided by the OEB to Contractor via FTP and will be PGP-encrypted.
- 2. The claim samples enumerated above shall be selected using methodology designed to ensure a 95% confidence level with a 1.5% precision rate. Once the samples have been selected, the sample files shall be returned to the OEB so the OEB can populate the de-identified fields with needed Personal Health Information ("PHI") and then returned to Contractor.
- D. In addition to other procedures considered necessary by Contractor to determine accuracy, the claims review process must include the following:
  - Computation of each claim selected for testing to determine its accuracy including analysis of any refunds due and/or payable.
  - Review of the nature of the claim to ascertain the allowable cost as defined in the contract, e.g., processed within the proper allowable amount charge guidelines, medical necessity guidelines, preexisting conditions exclusion, precertification requirements and other benefit limitations.
  - 3. Comparison of each claim to supporting documentation submitted by the individual or the provider of services to ensure that the claim reflects the documentation and that it is properly authorized for payment.
  - 4. Comparison of each claim to other claims for that individual with the same dates of service to ensure congruency of payment with all claims for the date of service.
  - Review of the imaged records, microfilm copies and source documents, if available, to see if there is any indication of fraud.
  - 6. Review to ensure the payment is not a duplicate payment.

- 7. Analysis of payment and denial errors by type of error to indicate the error types occurring most frequently and the dollar amounts associated with each error type. Analysis shall distinguish overpayments and erroneous payments from underpayments and erroneous denials and shall address the reasons for the over and underpayments.
- 8. Comparison of the current year audit results to industry norms shall also be made, if the information is available.
- 9. Review to determine if the administrator is following all procedures necessary to obtain a level of Coordination of Benefits ("COB") recoveries consistent with industry standards and the characteristics of the plan's participants.
- 10. Review of the member's specific coverage on the administrator's records compared to the coverage indicated on the OEB records.
- 11. Verification that the claimant is a System employee, retiree or other qualified participant and that the claimant was covered at the time the claim was incurred.
- E. Verify that the processing time from the date an addition, termination, or change of coverage initiated at the institution level to the date it is recorded by the administrator is in accordance performance standards. The time period for the first study shall be from September 1, 2016, through August 31, 2017.
- F. Verify that an adequate system of internal audits and claims processing controls are used by the Administrator to ensure the validity and accuracy of health claims payments.
- G. Review claims processing or other problem areas uncovered as a result of the audit which may warrant further detailed review. This summary shall emphasize areas of claims administration which, if changed or corrected, could result in cost savings to the System. Special emphasis shall be given to this section of the review and should be conducted by an experienced individual.
- H. Verify that an adequate system is used for determining the medical necessity of the claims submitted.

- Verify that adequate training procedures are used by the Administrator to ensure that recently hired personnel are adequately trained in claims processing.
- J. Verify that an adequate system is used by the administrator to identify potential areas of claims abuse such as fraudulent claims, duplicate claims, overcharging by providers, unnecessary physician services, etc. The adequacy of the system shall be determined by:
  - 1. Processing the fictitious test data and live transactions and analyzing the processing of the transactions. The tests shall be applied only to health claims.
  - 2. Analyzing information about the system of controls, e.g., number of probable fraudulent claims detected, dollar amount of overcharges, length of time between when a claim is processed and when it is identified as potentially fraudulent.
- K. Verify that an adequate system of program edits and claims processing procedures are in place to monitor and discover fraud, erroneous payments, duplicated payments, etc., for individuals who file a large volume of claims which may total several thousand dollars while each individual claim may be relatively small and, therefore, may escape some review processes.
- L. Analyze total amount of overpayments for each plan year by type of overpayment (hospital, provider, member), rate of collection of overpayment by type, total dollar amount of overpayments, total dollar amount of refunds collected, summary of reasons for overpayments, and recommended methods for reducing overpayments.
- M. Analyze administrator's management of the System's grievance appeal process, including the number of grievances which are referred to the administrator's Medical Division for additional review, the number of those referred which result in additional payment, and the percentage of these to the total number of grievance appeals processed.
- N. Verify the reasonableness of information reported on the Administrative Performance Report for the Plan Year.
- 3 <u>Services Required for an Audit of the UT SELECT Self-Funded Prescription</u>
  Drug Plan Administrator

The services consist of a review of both the mail order and retail pharmacy network (in and out of network) prescription processing for a combined total of 220 claims (the 20 largest prescriptions filled plus a random sample of 200 others) for the self-funded prescription drug plan. **The plan is currently administered by Express Scripts, Inc.** Claims must be selected from all pharmacy claims processed during the selected timeframe, which must be de-identified and provided by the OEB to Contractor via FTP and will be PGP-encrypted.

The audit of the self-funded prescription drug plan must concentrate on the time of service, dispensing accuracy, claim pricing, billings to the OEB, generic substitutions, Drug Utilization Review ("DUR") and fraud detection / prevention. A statistically valid sample in each of the areas listed must be selected so that the combined samples from all categories will not be less than 220 and will achieve at least a 95% confidence level with a 1.5% precision rate.

The first audit review of pharmacy claims processed must be for the time period of September 1, 2016, through August 31, 2017. Audit reviews must include the following reviews and / or tests:

- A. Initial receipt of prescription or refill requests via mail, Web site, fax or telephone.
- B. Fraud prevention and detection measures.
- C. Use of overrides and address changes.
- D. Accuracy and authenticity of received date.
- E. Accuracy and credibility of imaged or microfilmed records.
- F. Accuracy and effectiveness of backlog controls, processing in order of date received and collated processing of multiple prescriptions for the same person, which are submitted together and/or received by the plan administrator on the same date.
- G. Accuracy and security controls for the posting of co-payments received with prescriptions.
- H. The mail order pharmacy turn-around time as measured from the date the prescription is received to the date the drug is mailed to the plan participant. Contractor must review mail order claims from the facility with the highest percentage of scripts for the System participants for the fiscal year reviewed.
- Verify that the plan administrator's pricing accuracy is a function of the plan administrator's use of the most current average wholesale pricing ("AWP") and HCFA "MAC" pricing.
- J. Verify and report that the plan administrator accurately checks the proper co-payment is collected at the mail order pharmacy.
- K. Verify that the plan administrator utilizes fraud detection / prevention procedures on the retail pharmacy network claims.

- L. Validating a sample of point-of-sale transactions against the prescription document or by contacting the physician.
- M. Test a sample of refills issued by retail network pharmacies to determine if they were actually requested by the patient.
- N. Testing for validity of prescriptions ordered by telefax. Faxed orders should be from the physician only but can nevertheless be a source of fraud.
- O. Verification that the claimant is a System employee, retiree or other qualified participant and that the claimant was covered at the time the claim was incurred.
- P. Verify the reasonableness of information reported on the PBM Administrative Performance Report for the Plan Year.

# 5.3.4 <u>Services Required for an Audit of the UT Dental SELECT Self-Funded</u> Dental Plan Administrator

Review dental claims payments and processing procedures used by the System's self-funded Dental Plan administrator. The System has two self-funded dental plans-the basic plan and plus plan option. **The current plan administrator of both plans is DELTA DENTAL.** The scope shall not encompass a review of the financial statements of the Dental Plan administrator, nor an audit of its accounting records. However, some review of official records shall be required to ensure that the data used to develop the annual accounting statements are supported by accounting procedures and records. The project shall consist of the following:

- A. Review and verification of the accuracy and appropriateness of the annual accounting statements for Plan Year 2017. Review and verification must be sufficient to ensure that claims payments, administrative fee payments, the OEB reimbursements and all other information reported to the OEB are accurately reported and charged or related to the appropriate fiscal years. Additionally, the review shall determine the appropriateness of refunds to the plan as a result of the administrator's audits of dental office charges negotiated by the administrator.
- B. Review of the allowable charge procedures utilized by the Dental Plan administrator in the claims payment process to ensure that the allowable amounts are properly developed and updated to reflect the costs of dental care. The review must also include procedures utilized by the Dental Plan administrator on claims that require manual pricing. The review of allowable amounts must be for the allowances developed or used during Plan Year 2017.

For this purpose, a claim will be considered to have been processed if paid or denied or if an information request has been sent to the claimant. The number of days involved in the processing will be tabulated by counting the number of days between the date received and the date on which the determination is made and adding one day in recognition of the fact that a check or correspondence is unlikely to be mailed until the day after the determination is made.

- C. Verify the accuracy of claims process and payment. Review and ensure that transitional benefits are paid in accordance with the policies and procedures of the Dental Plan administrator. The first audit review of DELTA DENTAL claims processed shall be the time period from September 1, 2016 through August 31, 2017. Reviews will be conducted as follows:
  - 1. Two (2) statistically valid, stratified, random samples of dental claims. One (1) sample is to be selected from network dental claims, and a second (2) sample is to be selected from nonnetwork and out-of-area dental claims. Each sample shall include a significant number of dental claims for a total of approximately one hundred (100) dental claims. Claims must be selected from all dental claims processed during the selected timeframe, which must be de-identified and provided by the OEB (or plan administrator) to Contractor via FTP and will be PGP-encrypted.
  - 2. The samples enumerated above must be selected using methodology determined in consultation with and approved by the OEB. Samples must be designed to achieve 95% confidence level with a 1.5% precision rate. The stratified random samples of dental claims must be selected based on allocations of the samples to ranges (strata) by claim amount.
- D. In addition to other procedures considered necessary by Contractor to determine accuracy, the claims review process shall include the following:
  - 1. Computation of each claim selected for testing to determine its accuracy.
  - Review of the nature of the claim to ascertain the allowable cost as defined in the contract, e.g., processed within the proper allowable amount charge guidelines, dental necessity guidelines, preexisting conditions exclusion, and other benefit limitations.

- 3. Comparison of each claim to supporting documentation submitted by the individual or the provider of services to ensure that the claim reflects the documentation and that it is properly authorized for payment.
- Comparison of each claim to other claims for that individual with the same dates of service to ensure congruency of payment with all claims for the date of service.
- Review of the imaged records, microfilm copies and source documents, if available, to see if there is any indication of fraud.
- 6. Review to ensure the payment is not a duplicate payment.
- 7. Analysis of payment and denial errors by type of error to indicate the error types occurring most frequently and the dollar amounts associated with each error type. Analysis must distinguish overpayments and erroneous payments from underpayments and erroneous denials, and shall address the reasons for the over and underpayments.
- 8. Comparison of the current year audit results to industry norms must also be made, if the information is available.
- Review of the member's specific coverage on the administrator's records compared to the coverage indicated on the OEB records.
- 10. Verification that the claimant was a System employee, retiree or other qualified participant and that the claimant was covered at the time the claim was incurred.
- E. Verify that the processing time from the date an addition, termination, or change of coverage initiated at the agency level to the date updated by the plan administrator is recorded in a timely fashion.
- F. Verify that an adequate system of internal audits and claims processing controls is used by the administrator to ensure the validity and contractually correct processing and payment of health claims.

- G. A review of claims processing or other problem areas uncovered as a result of the audit which may warrant further detailed review. This summary must emphasize areas of claims administration which, if changed or corrected, could result in cost savings to the System. Special emphasis shall be given this section of the review and must be conducted by an experienced individual.
- H. Verify that an adequate system is used for determining the dental necessity of the claims submitted.
- I. Verify that adequate training procedures are used by the administrator to ensure that recently hired personnel are adequately trained in claims processing.
- J. Verify that an adequate system is used by the administrator to identify potential areas of claims abuse such as fraudulent claims, duplicate claims, overcharging by providers, unnecessary dental services, etc. The adequacy of the system must be determined by:
  - 1. Processing the fictitious test data and live transactions and analyzing the processing of the transactions. The tests must be applied only to dental claims. Contractor's findings from the tests must be enumerated in an exhibit to the final report.
  - 2. Analyzing information about the system of controls, e.g., number of probable fraudulent claims detected, dollar amount of overcharges, length of time between when a claim is processed and when it is identified as potentially fraudulent.
- K. Verify that an adequate system of program edits and claims processing procedures are in place to monitor and discover fraud, erroneous payments, duplicated payments, etc., for individuals who file a large volume of claims which may total several thousand dollars while each individual claim may be relatively small and, therefore, may escape some review processes.
- L. An analysis of the total amount of overpayments for each Fiscal Year by type of overpayment (provider, member), rate of collection of overpayment by type, total dollar amount of overpayments, total dollar amount of refunds collected, summary of reasons for overpayments, and recommended methods for reducing overpayments.

- M. An analysis of the administrator's management of the grievance appeal process, including the number of grievances which are referred to the administrator for additional review, the number of those referred which result in additional payment, and the percentage of these to the total number of grievance appeals processed.
- N. Verify the reasonableness of information reported on the Administrative Performance Report for the Plan Year.

<b>EXPENSES AND DISBURSEMENTS:</b> Contractor will be reimbursed without mark-up for reasonable expenses (including meals, rental car or mileage, coach class airfare, and lodging) validly incurred directly and solely in support of the Project and approved by University in advance. <u>Provided, however, Contractor agrees and acknowledges that Contractor will be subject to the then-current Travel Reimbursement Rates promulgated by the Comptroller of Public Accounts for the State of Texas at <a href="https://fmx.cpa.state.tx.us/fm/travel/travelrates.php">https://fmx.cpa.state.tx.us/fm/travel/travelrates.php</a> with regard to meals, mileage, Contractor agrees and acknowledges that Contractor will not be reimbursed by University for expenses that are prohibited or that exceed the allowable amounts provided in the then-current Travel Reimbursement Rates. As a condition precedent to receiving reimbursement for expenses and disbursements, Contractor will submit to University receipts, invoices, and other documentation as requested University.</u>
Notwithstanding the foregoing, reimbursement for expenses and disbursements will not exceed a maximum of \$ (Expense Cap) without the prior written approval of University.

WHEREAS, Covered Entity has entered or is entering into that certain Agreement with Business Associate ("the Underlying	n

WHEREAS, Covered Entity possesses Protected Health Information that is protected under HIPAA and the HIPAA Regulations, HITECH Act and state law, including the Medical Records Privacy Act (MRPA), and is permitted to manage such information only in accordance with HIPAA and the HIPAA Regulations, HITECH Act, and MRPA;

WHEREAS, Business Associate may receive such information from Covered Entity, or create, receive, maintain or transmit such information on behalf of Covered Entity, in order to perform certain of the services under the Underlying Agreement;

WHEREAS, the Parties desire to comply with health information privacy and security protections subsequent to the enactment of the HITECH Act, Subtitle D of the American Recovery and Reinvestment Act of 2009 which has established requirements for compliance with HIPAA. In particular, the requirements provide that: (1) Covered Entity give affected individuals notice of security breaches affecting their PHI, and Business Associate give notice to Covered Entity pursuant to the provisions below; (2) Business Associate comply with the HIPAA security regulations; and (3) additional and/or revised provisions be included in Business Associate Agreement;

WHEREAS, Under HIPAA and HITECH, Covered Entity is required to enter into protective agreements, generally known as "business associate agreements," with certain downstream entities that will be entrusted with HIPAA-protected health information;

WHEREAS, Covered Entity wishes to ensure that Business Associate will appropriately safeguard Protected Health Information.

NOW THEREFORE, Covered Entity and Business Associate agree as follows:

1. Definitions. The Parties agree that the following terms, when used in this Agreement, shall have the following meanings, provided that the terms set forth below shall be deemed to be modified to reflect any

changes made to such terms from time to time as defined in HIPAA and the HIPAA Regulations and the MRPA. All capitalized terms used in this Agreement but not defined below shall have the meaning assigned to them under the HIPAA Regulations.

- a. "Breach" shall have the meaning given such term under 45 C.F.R. § 164.402 as such regulation is revised from time to time.
- b. "Breach of System Security" means unauthorized acquisition of computerized data that compromises the security, confidentiality, or integrity of Sensitive Personal Information maintained by a person, including data that is encrypted if the person accessing the data has the key required to decrypt the data.
- c. "Business Associate" means, with respect to a Covered Entity, a
  person who:
  - 1) on behalf of such Covered Entity or of an Organized Health Care Arrangement (as defined under the HIPAA Regulations) in which the Covered Entity participates, but other than in the capacity of a member of the workplace of such Covered Entity or arrangement, creates, receives, maintains, or transmits PHI for a function or activity regulated by HIPAA, HIPAA Regulations, or MRPA including claims processing or administration, data analysis, processing or administration, utilization review, quality assurance, patient safety activities listed at 42 C.F.R. 3.20, billing, benefit management, practice management, and repricing; or
  - 2) provides, other than in the capacity of a member of the workforce of such Covered Entity, legal, actuarial, accounting, consulting, Data Aggregation, management, administrative, accreditation, or financial services to or for such Covered Entity, or to or for an Organized Health Care Arrangement in which the Covered Entity participates, where the provision of the service involves the disclosure of PHI from such Covered Entity or arrangement, or from another Business Associate of such Covered Entity or arrangement, to the person.
- d. "Data Aggregation" means, with respect to PHI created or received by Business Associate in its capacity as the Business Associate of Covered Entity, the combining of such PHI by Business Associate with the PHI received by Business Associate of another covered entity, to permit data analyses that relate to the health care operations of the respective covered entities.
- e. "HIPAA" means the Health Insurance Portability and Accountability Act of 1996, Public Law 104-191.
- f. "HIPAA Regulations" means the regulations promulgated under HIPAA by the United States Department of Health and Human Services, including, but not limited to, 45 C.F.R. Part 160 and 45 C.F.R. Part 164 subparts A and E ("The Privacy Rule") and the Security Standards as they may be amended from time to time, 45 C.F.R. Parts 160, 162 and 164, Subpart C ("The Security Rule").

- g. "HITECH Act" means the provisions of Division A, Title XIII of the American Recovery and Reinvestment Act of 2009, known as The Health Information Technology for Economic and Clinical Health, Act 42 U.S.C. §3000 et. seq., and implementing regulations and guidance, including the regulations implemented in 78 Fed. Reg. 5566 (January 25, 2013).
- h. "Individually Identifiable Health Information" means information that is a subset of health information, including demographic information collected from an individual, and:
  - 1) is created or received by a health care provider, health plan, employer, or health care clearinghouse; and
  - 2) relates to past, present, or future physical or mental health or condition of an individual; the provision of health care to an individual; or the past, present, or future payment for the provision of health care to an individual; and
    - a) that identifies the individual; or
    - b) with respect to which there is a reasonable basis to believe the information can be used to identify the individual.
- i. "MRPA" means Texas Medical Records Privacy Act, as codified in Section 181 et seq. of the Texas Health and Safety Code and as implemented through regulations including the Standards Relating to the Electronic Exchange of Health Information, codified at Title 1, Section 390.1 et seq. of the Texas Administrative Code.
- j. "Protected Health Information" or "PHI" means Individually Identifiable Health Information that is transmitted by electronic media; maintained in any medium described in the definition of the term electronic media in the HIPAA Regulations; or transmitted or maintained in any other form or medium. The term excludes Individually Identifiable Health Information in educational records covered by the Family Educational Right and Privacy Act, as amended, 20 U.S.C. § 1232g; records described at 20 U.S.C. § 1232g(a)(4)(B)(iv); and employment records held by a Covered Entity in its role as employer and regarding a person who has been deceased more than 50 years.
- k. "Security Incident" means the attempted or successful unauthorized access, use, disclosure, modification, or destruction of information or interference with systems operations in an information system, but does not include minor incidents that occur on a routine basis, such as scans, "pings", or unsuccessful random attempts to penetrate computer networks or servers maintained by Business Associate.
- 1. "Sensitive Personal Information" means: (1) an individual's first name or first initial and last name in combination with any one or more of the following items, if the name and the items are not encrypted: (a) social security number; (b) driver's license number or governmentissued identification number; (c) account number or credit or debit card number in combination with any required security code, access,

code, or password that would permit access to an individual's financial account; or (2) PHI information that identifies an individual and relates to: (a) the physical or mental health or condition of the individual; (b) the provision of health care to the individual; or (c) payment for the provision of health care to the individual.

- m. "Unsecured PHI" means PHI that is not rendered unusable, unreadable, or indecipherable to unauthorized individuals through the use of a technology or methodology specified in the guidance issued under Section 13402(h)(2) of the HITECH Act on the HHS web site.
- 2. Permitted Uses and Disclosures.
  - a. Compliance with Law. Covered Entity and Business Associate agree to comply with HIPAA, HIPAA Regulations, the HITECH Act, and the MRPA.
  - b. Performance of Services. Except as otherwise permitted by this Agreement, Business Associate may create, receive, maintain or transmit PHI on behalf of Covered Entity only in connection with the performance of the services contracted for in the Underlying Agreement or as Required by Law (as that term is defined by 45 C.F.R. § 164.103).
  - Proper Management and Administration. Business Associate may use PHI it receives in its capacity as Covered Entity's Business Associate for the proper management and administration of Business Associate in connection with the performance of services in the Underlying Agreement, as permitted by this Agreement or as Required by Law (as that term is defined by 45 C.F.R. § 164.103), and to carry out the legal responsibilities of Business Associate. Business Associate may also disclose Covered Entity's PHI for such proper management and administration of Business Associate and to carry out the legal responsibilities of Business Associate. Any such disclosure of PHI shall only be made in accordance with the terms of this Agreement, including Section 5(c) if to an agent or subcontractor of Business Associate, and only if Business Associate obtains reasonable written assurances from the person to whom the PHI is disclosed that: (1) the PHI will be held confidentially and used or further disclosed only as required by law or for the purpose for which it was disclosed to the person, and (2) Business Associate will be notified by such person of any instances of which it becomes aware in which the confidentiality of the PHI has been breached.
  - d. Data Aggregation. Business Associate may use and disclose PHI received by Business Associate in its capacity as Covered Entity's business associate in order to provide Data Aggregation services relating to Covered Entity's health care operations only with Covered Entity's permission.
  - e. Business Associate may use and disclose de-identified health information if written approval from the Covered Entity is obtained, and the PHI is de-identified in compliance with the HIPAA Rules.

#### 3. Nondisclosure.

a. As Provided in Agreement. Business Associate shall not use or further disclose Covered Entity's PHI other than as permitted or

required by this Agreement or as Required by Law (as that term is defined by 45 C.F.R. § 164.103).

- b. Disclosures Required By Law. Business Associate shall not, without prior written consent of Covered Entity, disclose any PHI on the possibility that such disclosure is required by law without notifying, to the extent legally permitted, Covered Entity so that the Covered Entity shall have an opportunity to object to the disclosure and to seek appropriate relief. If Covered Entity objects to such a disclosure, Business Associate, shall, to the extent permissible by law, refrain from disclosing the PHI until Covered Entity has exhausted all alternatives for relief. Business Associate shall require reasonable assurances from persons receiving PHI in accordance with Section 2(c) that such persons will provide Covered Entity with similar notice and opportunity to object before disclosing PHI when a disclosure is required by law.
- c. Additional Restrictions. If Covered Entity notifies Business Associate that Covered Entity has agreed to be bound by additional restrictions on the uses or disclosures of Covered Entity's PHI pursuant to HIPAA or the HIPAA Regulations, Business Associate shall be bound by such additional restrictions and shall not disclose Covered Entity's PHI in violation of such additional restrictions to the extent possible consistent with Business Associate's obligations set forth in the Underlying Agreement.
- Restrictions Pursuant to Subject's Request. If Business Associate has knowledge that an individual who is the subject of PHI in the custody and control of Business Associate has requested restrictions on the disclosure of PHI, Business Associate must comply with the requested restriction if (a) the Covered Entity agrees to abide by the restriction; or (b) the disclosure is to a health plan for purposes of carrying out payment or health care operations and the PHI pertains solely to a health care item or service for which Covered Entity has been paid out of pocket in full. If the use or disclosure of PHI in this Agreement is based upon an Individual's specific authorization for the use or disclosure of his or her PHI, and the Individual revokes such authorization, the effective date of such authorization has expired, or such authorization is found to be defective in any manner that renders it invalid, Business Associate shall, if it has notice of such revocation, expiration, or invalidity, cease the use and disclosure of the Individual's PHI except to the extent it has relied on such use or disclosure, or if an exception under the Privacy Rule expressly applies.
- e. Remuneration. Business Associate shall not directly or indirectly receive remuneration in exchange for disclosing PHI received from or on behalf of Covered Entity except as permitted by HITECH Act § 13405, the MRPA, and any implementing regulations that may be promulgated or revised from time to time.

- f. Disclosure. Business Associate shall not use or disclose PHI in a manner that would violate Subpart E of 45 C.F.R. part 164, or MRPA, if done by the Covered Entity itself except as authorized under Section 2 of this Agreement.
- 4. Minimum Necessary. Business Associate shall limit its uses and disclosures of, and requests for, PHI, to the minimum amount of PHI necessary to accomplish the intended purpose of the use, disclosure or request.
- 5. Additional Business Associate Obligations.
  - a. Safeguards. Business Associate shall use appropriate safeguards and comply with Subpart C of 45 C.F.R. 164 with respect to electronic PHI to prevent use or disclosure of the PHI other than as provided for by this Agreement. Business Associate shall implement administrative, physical and technical safeguards that reasonably and appropriately protect the confidentiality, integrity, and availability of any paper or electronic PHI it creates, receives, maintains, or transmits on behalf of Covered Entity.
  - b. To the extent the Business Associate is to carry out one or more of Covered Entity's obligation(s) under the Privacy Rule, Business Associate shall comply with the requirements of the Privacy Rule that apply to the Covered Entity in the performance of the obligations.
  - c. Business Associate's Agents and Subcontractors.
    - 1) Business Associate shall ensure that any agents and subcontractors to whom it provides PHI agree to only create, receive, maintain or transmit PHI on behalf of the Business Associate under the same restrictions that apply to Business Associate. Such agreement between Business Associate and subcontractor or agent must be in writing and must comply with the terms of this Agreement and the requirements outlined at 45 C.F.R. §164.504(e)(2); 45 C.F.R. §164.502(e)(1)(ii); 45 C.F.R. §164.314; and 45 C.F.R. §164.308(b)(2). Additionally, Business Associate shall ensure agent or subcontractor agree to and implement reasonable and appropriate safeguards to protect PHI.
    - 2) If Business Associate knows of a pattern of activity or practice of its subcontractor or agent that constitutes a material breach or violation of the agent or subcontractor's obligation under the contract or other arrangement, the Business Associate must take steps to cure the breach and end the violation and if such steps are not successful, must terminate the contract or arrangement if feasible. If it is not feasible to terminate the contract, Business Associate must promptly notify the Covered Entity.
  - d. Reporting. Business Associate shall, as soon as practicable but not more than five (5) business days after becoming aware of any successful security incident or use or disclosure of Covered Entity's PHI or Sensitive Personal Information in violation of this Agreement, report any such use or disclosure to Covered Entity. With the exception of law enforcement delays that satisfy the requirements under 45 C.F.R. § 164.412 or as otherwise required by applicable state law, Business

Associate shall notify Covered Entity in writing without unreasonable delay and in no case later than ten (10) calendar days upon discovery of a Breach of Unsecured PHI or Breach of Security System. Such notice must include, to the extent possible, the name of each individual whose Unsecured PHI or Sensitive Personal Information has been, or is reasonably believed by Business Associate to have been, accessed, acquired, or disclosed during such breach. Business Associate shall also provide, to the extent possible, Covered Entity with any other available information that Covered Entity is required to include in its notification to individuals under 45 C.F.R. § 164.404(c) and Section 521.053, Texas Business & Commerce Code at the time of Business Associate's notification to Covered Entity or promptly thereafter as such information becomes available. For purposes of this Agreement, a Breach of Unsecured PHI or Breach of Security System shall be treated as discovered by Business Associate as of the first day on which such breach is known to Business Associate (including any person, other than the individual committing the breach, who is an employee, officer, or other agent of Business Associate, as determined in accordance with the federal common law of agency) or should reasonably have been known to Business Associate following the exercise of reasonable diligence.

- e. Mitigation. Business Associate shall have procedures in place to mitigate, to the maximum extent practicable, any deleterious effect from any Use or Disclosure (as defined by 45 C.F.R. §160.103).
- f. Sanctions. Business Associate shall apply appropriate sanctions in accordance with Business Associate's policies against any employee, subcontractor or agent who uses or discloses Covered Entity's PHI in violation of this Agreement or applicable law.
- Covered Entity's Rights of Access and Inspection. From time to time upon reasonable notice, or upon a reasonable determination by Covered Entity that Business Associate has breached this Agreement, Covered Entity may inspect the facilities, systems, books and records of Business Associate related to the use and disclosure of PHI received from, or created or received by Business Associate on behalf of Covered Entity or the safequarding of such PHI to monitor compliance with this Agreement. Business Associate shall document and keep current such security measures and safeguards and make them available to Covered Entity for inspection upon reasonable request including summaries of any internal or external assessments Business Associate performed related to such security controls and safeguards. The fact that Covered Entity inspects, or fails to inspect, or has the right to inspect, Business Associate's facilities, systems and procedures does not relieve Business Associate of its responsibility to comply with this Agreement, nor does Covered Entity's (1) failure to detect or (2) detection but failure to require Business Associate's remediation of any unsatisfactory practices, constitute acceptance of such practice or a waiver of Covered Entity's enforcement or termination rights under this Agreement. This Section shall survive termination of this Agreement.
- h. United States Department of Health and Human Services. Business Associate shall make its internal practices, books and records relating to the use and disclosure of PHI received from, or created or received by Business Associate on behalf of, Covered Entity available to the

Secretary of the United States Department of Health and Human Services for purposes of determining Covered Entity's compliance with HIPAA and the HIPAA regulations, provided that Business Associate shall promptly notify Covered Entity upon receipt by Business Associate of any such request for access by the Secretary of the United States Department of Health and Human Services, and shall provide Covered Entity with a copy thereof as well as a copy of all materials disclosed pursuant thereto, unless otherwise prohibited by law.

- i. Training. Business Associate shall provide such training in the privacy and security of PHI to its Workforce (as that term is defined by 45 C.F.R. § 160.103) as is required for Business Associate's compliance with HIPAA, HIPAA Regulations, HITECH, and the MRPA.
- 6. Obligation to Provide Access, Amendment and Accounting of PHI.
  - a. Access to PHI. Business Associate shall make available to Covered Entity, in the time and manner designated by the Covered Entity, such information as necessary to allow Covered Entity to meet its obligations under the HIPAA Regulations, PHI contained in a Designated Record Set held by Business Associate as Covered Entity may require to fulfill Covered Entity's obligations to provide access to, and copies of, PHI in accordance with HIPAA and the HIPAA Regulations and MRPA. In the event that any individual requests access to PHI directly from Business Associate, Business Associate shall notify Covered Entity within five (5) business days that such request has been made.
  - b. Amendment of PHI. Business Associate shall make available to Covered Entity PHI contained in a Designated Record Set held by Business Associate as Covered Entity may require to fulfill Covered Entity's obligations to amend PHI in accordance with HIPAA and the HIPAA Regulations. In addition, Business Associate shall, as directed by Covered Entity, incorporate any amendments to Covered Entity's PHI into copies of such information maintained by Business Associate. In the event that any individual requests amendment of PHI directly from Business Associate, Business Associate shall forward such request to Covered Entity within five (5) business days.
  - c. Accounting of Disclosures of PHI.
    - 1) Record of Disclosures. Business Associate shall maintain a record of all disclosures of PHI received from, or created or received by Business Associate on behalf of, Covered Entity, except for those disclosures identified in Section 6(c)(2) below, including the date of the disclosure, the name and, if known, the address of the recipient of the PHI, a brief description of the PHI disclosed, and the purpose of the disclosure which includes an explanation of the reason for such disclosure. Business Associate shall make this record available to Covered Entity upon Covered Entity's request. If Business Associate maintains records in electronic form, Business Associate shall account for all disclosures made during the period of three (3) years preceding the request. In the event that any individual requests an accounting of disclosures of PHI directly from Business Associate, Business Associate shall notify Covered Entity within

- five (5) business days that such request has been made and provide Covered Entity with a record of disclosures within ten (10) days of an individual's request. If the request from an individual comes directly to Covered Entity and Covered Entity notifies Business Associate that it requires information from Business Associate in order to respond to the individual, Business Associate shall make available to Covered Entity such information as Covered Entity may require within ten (10) days from the time of request by Covered Entity.
- 2) Certain Disclosures Need Not Be Recorded. The following disclosures need not be recorded:
  - a) disclosures to carry out Covered Entity's treatment, payment and health care operations as defined under the HIPAA Regulations;
  - b) disclosures to individuals of PHI about them as provided by the HIPAA Regulations;
  - c) disclosures for Covered Entity's facility's directory, to persons involved in the individual's care, or for other notification purposes as provided by the HIPAA Regulations;
  - d) disclosures for national security or intelligence purposes as provided by the HIPAA Regulations;
  - e) disclosures to correctional institutions or law enforcement officials as provided by the HIPAA Regulations;
  - f) disclosures that occurred prior to the later of (i) the Effective Date or (ii) the date that Covered Entity is required to comply with HIPAA and the HIPAA Regulations;
  - g) disclosures pursuant to an individual's authorization in accordance with HIPAA and the HIPAA Regulations; and
  - h) any other disclosures excepted from the right to an accounting by the HIPAA Regulations.
- 7. Material Breach, Enforcement and Termination.
  - a. Term. This Agreement shall become effective on the Effective Date and shall continue unless or until this Agreement terminates, the Underlying Agreement terminates, or the Business Associate has completed performance of the services in the Underlying Agreement, whichever is earlier.
  - b. Termination. Either Party may terminate this Agreement:
    - 1) immediately if the other Party is finally convicted in a criminal proceeding for a violation of HIPAA or the HIPAA Regulations;

- 2) immediately if a final finding or stipulation that the other Party has violated any standard or requirement of HIPAA or other security or privacy laws is made in any administrative or civil proceeding in which the other Party has been joined; or completed performance of the services in the Underlying Agreement, whichever is earlier.
- 3) pursuant to Sections 7(c) or 8(b) of this Agreement.
- c. Remedies. Upon a Party's knowledge of a material breach by the other Party, the non-breaching Party shall either:
  - 1) provide an opportunity for the breaching Party to cure the breach and end the violation or terminate this Agreement and the Underlying Agreement if the breaching Party does not cure the breach or end the violation within ten (10) business days or a reasonable time period as agreed upon by the non-breaching party; or
  - 2) immediately terminate this Agreement and the Underlying Agreement if cure is not possible.
- d. Injunctions. Covered Entity and Business Associate agree that any violation of the provisions of this Agreement may cause irreparable harm to Covered Entity. Accordingly, in addition to any other remedies available to Covered Entity at law or in equity, Covered Entity shall be entitled to seek an injunction or other decree of specific performance with respect to any violation of this Agreement or explicit threat thereof, without any bond or other security being required and without the necessity of demonstrating actual damages.
- e. Indemnification. This indemnification provision is enforceable against the Parties only to the extent authorized under the constitution and laws of the State of Texas. The Parties will indemnify, defend and hold harmless each other and each other's respective employees, directors, officers, subcontractors, agents or other members of its workforce, each of the foregoing hereinafter referred to as "indemnified party," against all actual and direct losses suffered by the indemnified party and all liability to third parties arising from or in connection with any breach of this Agreement or of any warranty hereunder or from any negligence or wrongful acts or omissions, including failure to perform its obligations under MRPA, HIPAA, the HIPAA Regulations, and the HITECH Act by the indemnifying party or its employees, directors, officers, subcontractors, agents or other members of its workforce.
- f. Breach of PHI and Breach of System Security. Business Associate will pay or reimburse Covered Entity for all costs and penalties incurred by Covered Entity in connection with any incident giving rise to a Breach of PHI and/or a Breach of System Security, including without limitation all costs related to any investigation, any notices to be given, reasonable legal fees, or other actions taken to comply with HIPAA, the HITECH Act, or any other applicable law or regulation, where (i) the PHI was in the custody or control of Business Associate when the Breach of PHI and/or Breach of System Security occurred, or (ii) the Breach of PHI and/or Breach of System Security was caused by

the negligence or wrongful acts or omissions of Business Associate and its employees, directors, officers, subcontractors, agents or other members of its workforce.

#### 8. General Provisions.

- a. State Law. Nothing in this Agreement shall be construed to require Business Associate to use or disclose PHI without written authorization from an individual who is a subject of the PHI, or written authorization from any other person, where such authorization would be required under state law for such use or disclosure.
- b. Amendment. Covered Entity and Business Associate agree to enter into good faith negotiations to amend this Agreement to come into compliance with changes in state and federal laws and regulations relating to the privacy, security and confidentiality of PHI. Covered Entity may terminate this Agreement upon thirty (30) days written notice in the event that Business Associate does not promptly enter into an amendment that Covered Entity, in its sole discretion, deems sufficient to ensure that Covered Entity will be able to comply with such laws and regulations.
- c. No Third Party Beneficiaries. Nothing express or implied in this Agreement is intended or shall be deemed to confer upon any person other than Covered Entity, Business Associate, and their respective successors and assigns, any rights, obligations, remedies or liabilities.
- d. Ambiguities. The Parties agree that any ambiguity in this Agreement shall be resolved in favor of a meaning that complies and is consistent with applicable law protecting the privacy, security, and confidentiality of PHI, including, without limitation, MRPA, HIPAA, the HIPAA Regulations, and the HITECH Act.
- e. Primacy. To the extent that any provision of this Agreement conflicts with the provision of any other agreement or understanding between the Parties, this Agreement shall control.
- f. Destruction/Return of PHI. Business Associate agrees that, pursuant to 45 C.F.R. § 164.504(e)(2)(ii)(I), upon termination of this Agreement or the Underlying Agreement, for whatever reason,
  - 1) It will return or destroy all PHI, if feasible, received from or created or received by it on behalf of Covered Entity that Business Associate maintains in any form, and retain no copies of such information which for purposes of this Agreement shall mean all backup tapes. Prior to doing so, Business Associate further agrees to recover any PHI in the possession of its subcontractors or agents. An authorized representative of Business Associate shall certify in writing to Covered Entity, within thirty (30) days from the date of termination or other expiration of the Underlying Agreement, that all PHI has been returned or disposed of as provided above and that Business Associate or its subcontractors or agents no longer retain any such PHI in any form.

- 2) If it is not feasible for Business Associate to return or destroy said PHI, Business Associate will notify the Covered Entity in writing. The notification shall include a statement that the Business Associate has determined that it is infeasible to return or destroy the PHI in its possession, and the specific reasons for such determination. Business Associate shall comply with the Security Rule and extend any and all protections, limitations and restrictions contained in this Agreement to Business Associate's use and/or disclosure of any PHI retained after the termination of this Agreement, and to limit any further uses and/or disclosures to the purposes that make the return or destruction of the PHI infeasible.
- 3) If it is infeasible for Business Associate to obtain, from a subcontractor or agent any PHI in the possession of the subcontractor or agent, Business Associate must provide a written explanation to Covered Entity and require the subcontractors and agents to agree to comply with the Security Rule and extend any and all protections, limitations and restrictions contained in this Agreement to the subcontractors' and/or agents' use and/or disclosure of any PHI retained after the termination of this Agreement, and to limit any further uses and/or disclosures to the purposes that make the return or destruction of the PHI infeasible.
- g. Offshore Work. In performing the functions, activities or services for, or on behalf of Covered Entity, Business Associate shall not, and shall not permit any of its agents or subcontractors who receive Covered Entity's PHI to, transmit or make available any PHI to any entity or individual outside the United States without prior written consent of Covered Entity.
- h. Integration. This Agreement embodies and constitutes the entire agreement and understanding between the Parties with respect to the subject matter hereof and supersedes all prior oral or written agreements, commitments and understandings pertaining to the subject matter hereof.
- i. Governing Law. This Agreement is governed by, and shall be construed in accordance with, applicable federal law and the laws of the State of Texas without regard to choice of law principles.
- j. Notices. Any notices to be given hereunder to a Party shall be made via U.S. Mail or express courier to such Party's address given below, and/or (other than for the delivery of fees) via facsimile to the facsimile telephone numbers listed below.

Each Party named above may change its address and that of its representative for notice by the giving of notice thereof in the manner herein above provided.

- k. Privilege. Notwithstanding any other provision in this Agreement, this Agreement shall not be deemed to be an agreement by Business Associate to disclose information that is privileged, protected, or confidential under applicable law to the extent that such privilege, protection or confidentiality (a) has not been waived or (b) is not superseded by applicable law.
- 1. Multiple Counterparts. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and all of which shall together constitute one and the same instrument. Facsimile and electronic (pdf) signatures shall be treated as if they are original signatures.
