1. Increase the account for Clerical Assistants, and Office and Travel by \$700 from Central Administration Unallocated Balance.

EXPENSES OF PERMANENT UNIVERSITY FUND BOND ISSUE: Create a new account for the expenses of the 1959 bond issue and approve an appropriation of \$5,000 to this account from Available Fund Balance, transferring into this account the unused balance of \$3,246.63 in the 1949 refunding bond issue account. (3968)

RENEWAL OF BANK DEPOSITORY AGREEMENTS: All of the University's present bank depository contracts with the exception of the one with Texas National Bank, Houston, expire by their terms August 31, 1959. I recommend that Mr. Charles H. Sparenberg, Comptroller, be authorized to negotiate renewal agreements with each of the present banks (listed below), all agreements to be for the two-year period beginning September 1, 1959.

ADDITIONAL APPROPRIATION FOR CONSULTING ARCHITECT'S FEE ON UNDERGRADUATE LIBRARY AND ACADEMIC CENTER: At the Regents' Meeting of September 20, 1958, approval was given to an advance from the Available University Fund to cover preliminary expenses and that part of the Consulting Architect's fee on the Undergraduate Library and Academic Center at Main University which would be due before the appropriation was made for the building. At the June 13, 1959, meeting of the Regents approval was given to a set of preliminary plans which had an estimated construction cost of \$4,150,000. In order that payment may

be made to the Consulting Architect of the 1/2 of 1% fee which is due at this time, I recommend that an additional amount of \$7,550 be appropriated from the Unappropriated Balance of the Available University Fund to Account No. 94126 - Undergraduate Library and Academic Center - Consulting Architect's Fee - Jessen, Jessen, Millhouse, and Greeven, any payments made there from to be reimbursed to the Available Fund later from the proceeds of the Bond Issue.

REVISION OF TRUST AGREEMENT SETTING UP THE THOMAS FREDERIC BUSH SCHOLARSHIP FUND AND AUTHORIZATION OF CHAIRMAN TO SIGN NEW INSTRUMENT: Under date of August 4, 1941, Mary Adelaide Bush, Independent Executrix of the Estate of Thomas F. Bush, deceased, executed a Declaration of Trust creating the Thomas Frederic Bush Scholarship Fund by which certain securities were transferred to the Board of Regents of the University as Trustee. Mrs. Bush has now given 23 shares of the capital stock of International Business Machines Corporation (valued at approximately \$10,000) as an additional contribution to this fund. The revision of the original instrument gives wider scope to the selection of applicants and makes minor changes in the method of selecting them. The matter has the approval of Endowment Officer Stewart and Attorney Burnell Waldrep.

I recommend acceptance of the additional gift of IBM stock, that the thanks of the Board be sent to the donor by the Secretary, and that the Chairman be authorized to sign the instrument on behalf of the Board.





RECOMMENDATION OF THE COLLEGE OF ARTS AND SCIENCES

On page 28 of the Catalogue of the College of Arts and Sciences for 1957-1959 under "HONORS," "Graduation with honors" ADD as paragraph number 6

"In addition, certain departments in the College offer their own Honors Programs. These programs are set forth at the beginning of the departmental course offerings appearing in this catalogue. The minimum requirements for the completion of all such programs are (1) a B grade average for all courses taken at the University of Texas; (2) a three-semester-hour senior thesis or research project, or a reasonable equivalent; and (3) a comprehensive examination in the major field, or a reasonable equivalent. A college honors council, representing all departments offering honors programs, will act in a supervisory capacity. This council will pass upon the programs and standards required and will certify the individual students to the Dean on the successful completion of their programs. An additional notation of "Special Honors in name of department will appear on the diploma of any student who is certified as having successfully completed the Honors Program of that department."

Reason: To comply with instructions from the Faculty of the College of Arts and Sciences to the Special Committee on Departmental Honors Programs to draft a recommendation that would provide for a dual system of honors by continuing the existing program and allowing for the addition of departmental programs where desired.



LETTER OF CONCESSION which the National Institute of Anthropology and History, grants to Dr. Rex E. Gerald, as representative of the Centennial Museum, of the University of Texas, in order to carry on archaeological exploration and surveys on a small scale, in the states of Chihuahua and Coahuila, in accord with the Law concerning the Protection and Conservation of Archaeological and Historical Monuments and their control. Dr. Rex E. Gerald, as representative of the Centennial Museum, of the University of Texas and the National Institute of Anthropology and History, agree:

- 1st. The concessionaire will complete the field work in a period of two years, counted from the first of September of the current year.
- 2nd. Any article or monument that may be discovered during the work will be the property of the Mexican Nation and must not leave the country without previous permission, which only the Institute can give.
- 3rd. The Institute reserves the right to inspect the conduct of the work in whatever form it considers appropriate.
- 4th. The concessionaire shall give to the Institute monthly reports of the work completed accompanied by the appropriate illustrations. In case a discovery of extraordinary character is made the Institute itself will be advised by telegraph or telephone.
- 5th. The concessionaire obligates himself to publish the results of this work within two years, counted from the termination of the concession and to deliver to the Institute itself 50 examples of each one of the publications that result, the Institute being authorized to publicize the reports, or to translate and publish the results of the investigations.
- 6th. The concessionaire must make all the necessary arrangements and comply with the legal arrangements in effect in the matter of immigration and of temporary importation of articles.
- 7th. The Institute may effect at any time, such investigations that are judged convenient on the same sites as mentioned in this permit.





Dear Doctor Wilson:

I recommend that our catalogue with proposed changes for 1959-60 be submitted to the Board of Regents for approval. Changes have been made in the sections concerning the historical sketch, curriculum, grading system, and fees and deposits. Your attention is called to one major change which concerns the requirement of a baccalaureate degree as a pre-requisite for admission to the School of Medicine beginning with the class to matriculate in 1960. This statement has appeared as a footnote in both Medical School catalogues for the past three years.

I further recommend that we be permitted to publish separate catalogues for the School of Medicine, including the Graduate School and Medical Services Curricula, and for the School of Nursing. We have been informed that this will not increase materially the cost of publication and we feel separate catalogues will facilitate distribution to students who may be interested in only one school. We would plan to combine a small number of the two catalogues each year for mailing to Texas colleges and for use by administrative officers. We propose to print the Medical School catalogue as soon as it has been approved by the Regents and to submit changes in the catalogue for the School of Nursing for approval at the October meeting of the Regents.

PROPOSED CHANGES IN THE CATALOGUE FOR THE YEAR 1959-60

1. Page 15. Requirements for Admissions. Change paragraph 6 from

"Scholastic preparation for the study of medicine should include two types of intellectual discipline: the first, in the humanities, including English composition and literature, foreign language, history, philosophy and the social sciences; the second, in the sciences, including mathematics, physics, chemistry and biology. Since the traditionally high standard of medical practice requires a broad concept of human relations, maturity of judgment and a constantly increasing amount of scientific knowledge, it is strongly recommended that the candidate for admission pursue a four-year premedical curriculum. Furthermore, since many candidates will be refused admission, it is considered wise for each premedical student to follow a program which will satisfy the requirements for admission to medical school and, at the same time, lead to the B. A. degree.¹ Applicants who have been out of college, or have completed the majority of premedical courses four years or more prior to application, will be required to spend at least one semester and summer in review work prior to consideration by the Committee on Admissions. "

¹Beginning with the class to matriculate in September of 1960, 4 years of college work and the receipt of the baccalaureate degree will be required for admission. However, the Admissions Committee will reserve the right to accept for admission, a few students who have demonstrated outstanding academic qualifications and who are unquestionably mature physically, emotionally, and intellectually, but who have not fulfilled this requirement. "

"Scholastic preparation for the study of medicine should include two types of intellectual discipline: the first, in the humanities, including English composition and literature, foreign language, history, philosophy and the social sciences; the second, in the sciences, including mathematics, physics, chemistry and biology. 2. Page 16. Scholastic Requirements for Admission. Change paragraph 2 from

"Admission to The University of Texas Medical Branch, School of Medicine, requires credit for a minimum of ninety (90) semester hours of college courses, including fifty-six

(56) semester hours of prescribed courses from recognized and accredited colleges or universities."

to:

"Admission to The University of Texas Medical Branch, School of Medicine requires four years of college work and the receipt of the baccalaureate degree, including fifty-six (56) semester hours of prescribed courses from recognized and accredited colleges or universities."

3. Page 16. Scholastic Requirements for Admission. Paragraph 3. Eliminate sentence which reads:

"The applicant must also have met the admission requirements of the College of Arts and Sciences of The University of Texas."

4. Page 17. Legal and Regental Course Requirements. Eliminate 2nd paragraph which reads:

"Students planning to enter The University of Texas Medical Branch after three years of college preparation are urged to include six semester hours of American government and six semester hours of American history among the elective subjects required for admission to this School of Medicine. If the requirements in government and history are not satisfied before admission, they must be satisfied before a student can enter the junior year in medicine or at an equivalent time prior to receipt of degrees in other curricula. Courses to satisfy these requirements are offered by correspondence as well as in residence at the Main University in Austin."

5. Page 17. Legal and Regental Course Requirements. Add sentence to the 3rd paragraph to read:

"Students who have completed the baccalaureate degree before entering the Medical Branch must complete three semester credit hours of American government (equivalent to Government 610a at the Main University) either before entering Medical School or prior to entering the junior year. If a student is admitted to the School of Medicine of The University of Texas Medical Branch without the completion of a baccalaureate degree, he will be required to complete six semester hours of American government and six semester hours of American history prior to entering the junior year in medicine."

6. Page 22. Tuition, Fees and Deposits. Add sentence preceding "Filing Fee" to read:

"All fees for a semester are payable in full at the time of registration and a student is not registered until his fees are paid in full."

7. Page 22. Tuition, Fees and Deposits. Registration Deposit. Change from:

"Registration Deposit. --On acceptance by the School of Medicine, an applicant is required to send to the Registrar a certified check or money order for \$30.00. This will be applied to the laboratory and library deposit mentioned below when the student matriculates. The deposit is

forfeited if the student does not register. "

"Registration Deposit. --On acceptance by the School of Medicine, an applicant is required to send to the Director of Admissions a certified check or money order for \$30.00. This will serve as the laboratory and library deposit outlined below when the student matriculates. In accordance with the 'Traffic Rules', the deposit is forfeited if the student withdraws after the deadline or fails to matriculate in the year for which admission is granted. "

If at any time the deposit falls below \$15.00 the student will be notified and will be required to restore the deposit to its original amount. Whatever balance remains will be refunded to the student after graduation or on withdrawal from school. "

9. Page 22. Tuition, Fees and Deposits. Refund of Fees. Change from:

"Refund of Fees. --Refund of tuition and laboratory fees because of withdrawal from the school are arranged in accordance with rules of the Business Office. "

HISTORICAL SUMMARY AND FACILITIES

1860 - The first medical college in Texas was authorized in Galveston as the Medical Department of Soule University. Soule University was founded at Chappell Hill, Washington County, Texas, in 1856, under the supervision of the Texas Conference of the Methodist Episcopal Church South, but as far as the records go, the medical college did not function. The Civil War and the unhappy period of reconstruction probably halted the establishment of this college.

1866 - Immediately after the Civil War, the Galveston Medical College was organized under the auspices of Soule University. The college was located originally on the second floor of a frame building at the corner of 22nd and Postoffice Street and later moved to the south side of Avenue L somewhere between 21st and 23rd Streets. This medical college used the Island City Hospital, which was leased by the Dean, Greenville Dowell, M. D., as a teaching hospital. Dr. Dowell was the first to suggest the mosquito as the carrier of yellow fever (1876). The Island City Hospital became the City Hospital, to which the John Sealy Hospital succeeded, all having occupied the same site between Avenues A and B between 8th and 9th Streets. Dissensions arose and the college closed in 1873.

1873 - The Texas Medical College was organized under a charter which was intended to correct the defects of its predecessor. Ashbel Smith, M. D., was president of the Board of Trustees and Greenville Dowell, M. D., was professor of surgery. Dr. Smith was a pioneer physician who held many important positions. During the Republic he was a surgeon general under Sam Houston and later served as minister to the United States, Great Britain, France and Spain. He was instrumental in establishing The University of Texas and was president of the Board of Regents from 1882 to 1886.

1881 - By an act of the Legislature the location of the Main University and the School of Medicine was decided by popular vote of the people of Texas. Galveston was chosen over Houston by a vote of 29,741 to 12,386. Austin was chosen over Tyler as the site of the Main University. In order that it might not interfere with the Medical Department of The University of Texas, the Texas Medical College closed.

1883 - The University of Texas formally opened in Austin.

1884 - John Sealy bequeathed money to establish a hospital in Galveston. This bequest is described in the Medical Branch catalogue of 1893 as follows:

"It being represented to the citizens of Galveston and to the people of the State of Texas that John Sealy, late of the city of Galveston, departed this

life in the month of August, 1884, inspired with a generous and philanthropic motive, and possessed of a large real and personal estate, of which by his bequest he devoted \$75,000 to the establishment of a hospital in said city, naming for that purpose the city council of the city of Galveston and the Regents of The University of Texas, jointly, for and in behalf of the Medical Department of said University, to manage and conduct the same for the reception and relief of sick and diseased persons; the property of said hospital shall be exempt from taxation, and shall be entitled to the benefit and provisions of the law relative to charitable institutions.

"The Regents may take and hold any additional donations, grants, devises, and bequests in further support of or addition to said hospital.

"The direction, ownership, and disposition of said hospital shall be vested in said Regents and their successors, for the object and purposes heretofore set forth, and pursuant to the wishes and directions of the last will and testament of its founder aforesaid."

1887 - George Sealy, in accordance with the will of his late brother, John Sealy, offered to donate a hospital to belong to the State University provided the Legislature should make the necessary appropriations to organize the Medical School in Galveston. Although the Legislature failed to act at that time, the hospital was built and completed in 1889. Upon completion, this hospital was donated to the city of Galveston and designated the John Sealy Hospital.

1889 - Texas Medical College reorganized to staff the new John Sealy Hospital and to prepare the way for the new medical school.

Legislature appropriated \$60,000 for the medical college building in Galveston. This building was completed in 1890. The city of Galveston transferred the John Sealy Hospital, which was built at a cost of \$75,000, to the Board of Regents.

1891 - October 5. The first annual session of The University of Texas Medical Department was opened with fourteen first-year students, five second-year students and four third-year students. The curriculum covered a period of three academic years. The Texas Medical College closed and most of its faculty joined the University. Three students graduated in 1892, namely Thomas Flavin, Houston Thomas Guinn and Jesse P. Hendrick.

1893 - College of Pharmacy established in Galveston.

1897 - John Sealy College of Nursing established.

1900 - Medical course lengthened to four academic years. A devastating storm swept Galveston on September 8th of this year and the staff of the School of Medicine served heroically. Of 40,000 inhabitants, the storm left 6,000 dead, thousands of houses wrecked and millions of dollars worth of property destroyed. The John Sealy Hospital was damaged

and was repaired and altered in later years.

1901 - Negro hospital, a two story structure, was opened.

1912 - Isolation Hospital completed.

1914 - Women's Hospital completed at cost of \$125,000, gift of John Sealy and Jennie Sealy Smith.

1916 - Experimental laboratory and animal quarters. John Sealy Hospital enlarged and remodeled at a cost of \$260,000 by John Sealy.

1921 - Pharmacology laboratory completed.

1922 - In order to make adequate provisions for the Institution and program originated by their father's will, Mr. John Sealy II and his sister, Mrs. R. Waverley Smith, obtained a charter on March 1, 1922, for the Sealy and Smith Foundation for the John Sealy Hospital, a charitable corporation dedicated in perpetuity to use all of its resources "for the support, maintenance and repair of the John Sealy Hospital". The wills of the younger Mr. Sealy and Mrs. R. Waverley Smith bequeathed residual portions of their extensive estates to the Foundations.

1925 - Medical Laboratory Building (Keiller Building) completed.

1927 - College of Pharmacy moved to Austin.

1931 - Galveston State Psychopathic Hospital opened. This hospital became part of the Medical Branch by Legislative Act in 1945.

1932 - Keiller Building enlarged. Outpatient Clinic Building built by Sealy-Smith Foundation at a cost of \$500,000. Rebecca Sealy Nurses' residence completed. Old Nurses' Home converted to a psychiatric unit.

1937 - State Hospital for Crippled and Deformed Children completed. This building underwent alterations in 1950, 1951, and 1956 and now contains the Pediatric outpatient clinic, offices and laboratories on the first two floors and a premature nursery on the third floor. The other pediatric units are in the new John Sealy Hospital.

New Negro Hospital completed.

1944 - Mr. and Mrs. Maco Stewart donated their home, which is fifteen miles from the Medical Branch on Stewart Road, to the University. This home was originally used as a convalescent home for children, but transportation difficulties caused it to be closed. It is now used as a home for the Executive Director of the Medical Branch.

1953 - Gail Borden Building completed. This modern air conditioned laboratory building

was named for Dr. Gail Borden, an early physician in Galveston, who established the principles of evaporating milk in vacuo in his crude laboratory in Galveston. This building houses the laboratories of biochemistry, physiology, microbiology, pharmacology and the library.

1954 - New John Sealy Hospital and R. Waverley Smith Memorial Pavillion completed at a cost of approximately eleven million dollars and donated to the University by the Sealy Smith Foundation. All of the patients in the old John Sealy Hospital and Women's Hospital were transferred into the new hospital. The Women's Building was converted to administrative offices and the old John Sealy Hospital was partially converted into clinics, special laboratories and storage areas.

Rosa and Henry Ziegler Hospital opened. This facility was built at a cost of approximately \$775,000 by funds provided by the will of the late Mrs. Henry Ziegler of Galveston and has facilities for sixty patients with discases of the chest. Isolation Hospital converted to physical plant facility with the opening of this hospital.

1958 - Negro Hospital closed for repairs and remodeling.

1959 - School of Nursing transferred from Rebecca Sealy Nurses' Home to new air conditioned units (Brackenridge Hall). Rebecca Sealy Nurses' Home closed for repairs and remodeling.

Additional general and service buildings have been added over the years including a power plant, laundry, garage, general stores and warehouse. Several modern air conditioned dormitories and an auxiliary enterprises snack bar were completed in 1955 and 1956.

The Sealy and Smith Foundation and the estate of John Sealy have made expenditures in excess of twenty million dollars for the operation and development of the John Sealy Hospital. All hospital buildings are owned by The University of Texas and have been operated by the Board of Regents since 1941 except the R. Waverley Smith Memorial Pavillion, which under terms of the will of Mrs. Smith must remain the property of the Foundation. It is operated and is under control however, of the management of the John Sealy Hospital.

During the fiscal year 1957-58, The University of Texas Medical Branch Hospitals had a combined capacity of 926 beds. There were 14,469 patients admitted with a total of 286,142 patient days in hospital. One thousand five hundred and thirty-three babies were born in John Sealy Hospital. The University of Texas Clinics averaged 555 patients per day and operated five days each week. There were a total of 138,776 clinic visits.
